Review: Rationale for seeking the SUD 1115 Demonstration Waiver

Oregon gains through the SUD Demonstration Waiver:

- Increased capacity
 - Ability to approve SUD RES and WM programs for 17 or more beds
- Federal participation allowed for each bed over 16 per facility and campus
- Increased rates:
 - Specialty rates



Review: Rationale for seeking the SUD 1115 Demonstration Waiver, continued...

Oregon gains through the SUD Demonstration Waiver:

- Improved SUD system of care
 - Consistent assessment between levels of care
 - Clearly ASAM defined levels of care per program
 - Expanded Continuum of Care
- Under this demonstration beneficiaries will have access to high quality, evidence-based OUD/SUD treatment services across a comprehensive continuum of care, ranging from residential and inpatient treatment to ongoing chronic care for these conditions in cost-effective community-based settings.

Effective April 8, 2021



Review: ASAM Requirements per 1115 Waiver

- Oregon's continuum of care shall be based on the American Society of Addiction Medicine (ASAM) criteria.
- Providers assess treatment needs based on the American Society of Addiction Medicine (ASAM) Criteria.
- Establishment of a utilization management approach that includes an independent process for reviewing placement in residential.
- Establish a state-wide continuum of care that emphasizes the transition between levels of care.



Review: ASAM Requirements per 1115 Waiver, Continued...

- Establish SUD treatment provider qualifications in certification and licensure, policy & provider, managed care contracts, and credentialing that meet standards described in the ASAM Criteria; including levels of care, hours of clinical care, and credentials of staff for residential treatment, etc.
 - These requirements apply to every type of HSD certified and licensed SUD program throughout the State, regardless of funding source or level of care.



UPDATES

- Progress since April 6, 2022, Provider meeting:
 - Annual report to CMS was submitted.
 - New licenses were issued to all SUD RES and WM providers that contain the IMD and specialty services status, as applicable.
 - HSD is beginning to contract for ASAM implementation supports.
 - Specialty Programs OAR 309-018-0162 became effective on July 20, 2022



ASAM – Fidelity & Compliance

- The following actions must be effective no later than April 7, 2023:
 - Revising OARs: 309-008, 309-018, 309-019, 415-012, 415-020, 415-050, 415-057, and 415-065
 - When the above OAR revisions are effective, SUD Programs must apply for approval for each ASAM Level of Care rendered.
 - Applications for ASAM Levels of Care
 - Compliance Reviews will give providers a six month grace period to come into compliance from date rules are final.



ASAM Fidelity & Compliance, continued...

ASAM tools:

- HSD will provide training and resources to support Provider implementation
- HSD will use the ASAM compliance review tools
- HSD has scheduled a meeting with ASAM for Providers to learn about the ASAM assessment options (paper/ PDF, and software)

Future Provider meetings:

- Provider Focus group: to address implementation barriers
- Provider Informational meetings: about once a quarter to discuss updates
- Technical Assistance sessions with Licensing and Certification




ASAM Fidelity & Compliance, continued...

- Renewal reviews will use forms that adhere to ASAM Criteria standards for various aspects of the program, each level of care approved, and documentation relevant to ASAM Criteria, a fidelity review, and the applicable OARs
 - Service Record documentation must adhere to ASAM standards for documentation, including:
 - ASAM's assessment will be the only accepted version
 - Service plans
 - Transfer Summaries
- HSD may conduct informal reviews across a sample of programs to provide technical assistance and assess the implementation of ASAM across the system of care.
