Subject: Payment recovery planned for fee-for-service IMD residential per diem claims

The Oregon Health Authority (OHA) is reprocessing all fee-for-service per diem claims paid to Institutions of Mental Disease (IMD) residential programs from **July 1, 2022**, through **March 20, 2023**, to recover overpayments that exceed federally approved per diem rates.

OHA is also working to update the <u>Behavioral Health Fee-Schedule</u> to include all SUD residential per diem rates:

Program	Description	Rate
Adolescent programs	Serves ages 18 and under (any number of licensed beds)	\$415.50
IMD programs	Has 17 or more licensed beds	\$297.70
Non-IMD programs	Has 16 or fewer licensed beds	\$318.50
Specialty programs	<ul><li>Serves one of these populations (any number of licensed beds):</li><li>1. Culturally specific; including LGBTQIAS+ and military</li><li>2. Pregnant and/or parenting</li></ul>	\$400.40

## Why is this happening?

When applying the net 30-percent increase to codes H0018 and H0019 for IMD programs in OHA's claim system, OHA incorrectly calculated the increase as higher than the rate approved by the Centers for Medicare & Medicaid Services. On March 21, 2023, OHA updated the system to correct this error. The claim reprocessing will apply the correct payment to the claims listed above.

If your program experienced overpayments due to this error, OHA will reach out to discuss options for resolving the overpayments.

## What should you do?

## What you will see on the remittance advice

The Claim Adjustments section will list the affected claims by original Internal Claim Number (ICN).

- Each ICN will have an adjustment ICN (beginning with "52") to indicate recovery activity.
- The total amount recovered for the claim will be listed as a "Net Overpayment."

The **Financial Transactions** section will list the adjustment ICNs, recovery amounts and any outstanding balance with *EOB* 8400 – Accounts receivable has been established – The amount will be deducted from your future payments.
