Notice of intent – OHA will amend the Medicaid State Plan to increase fee-for-service rates for certain youth intensive treatment services.

Oregon Health Authority (OHA) will submit a State Plan Amendment (SPA) to increase fee-for-service youth intensive services rates as follows, effective July 1, 2026:

- Substance use disorder residential treatment facility rate, from \$444.24 to \$582.60
- Psychiatric Day Treatment rate, from \$342.13 to \$387.52
- Secure Inpatient Psychiatric facilities rate, from \$1630.36 to \$1713.78

The increase will cover the cost of care and staffing for these facilities. The estimated cost for the 2025-2027 biennium is approximately \$1.62 million.

13.d. Rehabilitative Mental Health Services

Payment methods for Rehabilitative Mental Health Services are a state-wide fee schedule. The Rehabilitative Mental Health fee schedule includes various provider types including MH outpatient services, residential treatment facilities (RTF) young adults in transition (YAT) services, Psychiatric day treatment services (PDTs), and secure inpatient psychiatric (SIP) services. The agency's fee schedule rate was set as of 7/1/261/4/24 and is effective for services provided on or after that date. ~~The statewide fee schedule rate will receive a 3.4% inflationary~~

~~adjustment effective July 1, 2024.~~ Except as otherwise noted in the plan, state-developed fee schedule rates are the same for both governmental and private providers of rehabilitative mental health services.
