Subject: New system for submitting and tracking CCO Contract deliverables

The Oregon Health Authority (OHA) is implementing a new system for submission and tracking of deliverable documentation related to the Coordinated Care Organization (CCO) Contract.

Why is this happening?

The new system will help streamline the CCO Contract Deliverable Process and include the following features:

- Simplification of the submission, review, and tracking of deliverable documentation;
- Self-service functionality;
- System-generated alerts and notifications;
- Replacement of most email submissions; and,
- Replacement of the interim system OHA staff are utilizing for tracking, reporting, and evaluation of CCO Contract deliverables.

What should you do?

Consult the deliverable submission crosswalk

CCOs should use the attached crosswalk to determine which CCO Contract deliverables should be submitted using the new system.

Request licenses for staff

CCO license requests received prior to June 28, 2023 have been submitted for processing. Additional licenses can be requested by emailing: HSD.QualityAssurance@odhsoha.oregon.gov.
