**Subject:** Fee-for-service rates for OHA/ODHS private during nursing services effective July 1, 2022.

On June 23, 2022, the Oregon Health Authority (OHA) updated the Medicaid fee-for-service rates for private duty nursing services effective July 1, 2022. These rates are for private duty nursing services administered by OHA and the Oregon Department of Human Services (ODHS).

### OHA Private Duty Nursing services: Approved and paid as an hourly rate.

Code	Description	Rate effective 7/1/2022
S9123	Nursing care, in the home, by registered nurse	\$71.61 per hour
S9124	Nursing care, in the home, by licensed practical nurse or licensed vocational nurse	\$44.61 per hour
