Subject: CY 2025 and 2026 deliverables due in Q1 CY 2026

This communication is a reminder about CCO contract deliverables for Contract Years (CY) 2025 and 2026 due in the first quarter of 2026. It is a compilation of information previously provided by the Oregon Health Authority (OHA) to CCOs via documents that include annual contract restatements, amendments, and memos. The template for each year's Medicaid Contract restatement is posted on the CCO Contract Forms [webpage](#). Most OHA memos about deliverables are posted on the CCO Contract Announcements [webpage](#).

All deliverables and citations in this document are based on the Medicaid Contract. Consistent with Section 4.3.5 in the General Provisions of the separate Non-Medicaid and OHP Bridge-Basic Health Program Contracts, a deliverable submitted under the Medicaid Contract also satisfies the requirements of those contracts unless expressly stated otherwise. If a deliverable in this document is specific to either of the other contracts, the applicable contract name is specified in the table heading.

This document only lists contract deliverables for which the due date is either explicitly stated in the applicable document or is calculable based on the information provided in the document. The deliverables are listed with the citation, due date, and submission method for each and sorted by due date and citation.

In the column below that specifies the submission method for each item, "Portal" means the CCO deliverables portal located at <https://oha-cco.powerappspartals.us>. "Portal form" means a data entry form provided within the portal.
