



## CCO Community Health Assessment (CHA) and Community Health Improvement Plan (CHP): 2021 Submission Instructions

The purpose of this notice is to remind CCOs of the upcoming due date for the submission of the **CHA and CHP or the CHP Progress Report** and provide the criteria that OHA will use to evaluate these submissions.

- ✓ CCOs that have not submitted a CHP within the last five years are required to submit a CHA and CHP. In addition, the CCO must submit a completed [CHA/CHP evaluation assessment](#) that documents how the CHA and CHP meet the evaluation criteria with reference to CHA/CHP content or to supplemental documentation.
- ✓ CCOs that have submitted a CHP in the last five years are required to submit a CHP Progress Report and a completed [CCO Community Health Improvement Plan Progress Report Questionnaire](#).

**The relevant submission must be submitted by June 30, 2021, to the CCO deliverables email box at [CCO.MCOPDeliverableReports@dhsoha.state.or.us](mailto:CCO.MCOPDeliverableReports@dhsoha.state.or.us).**

### For CCOs submitting a CHA and CHP:

For clarity and transparency, OHA has attached to this email the full list of criteria that will be used to evaluate the CHA and CHP submissions in the CHA/CHP evaluation assessment. The evaluation criteria will also be posted on the CCO Contract Forms [webpage](#). OHA will provide the evaluation results to each CCO within 8 weeks of the submission due date.

### For CCOs submitting a CHP Progress Report:

For clarity and transparency, OHA has attached to this email the full list of criteria that will be used to evaluate the progress report in the [2021-CHP-ProgressReport-Guidance document](#). The evaluation criteria will also be posted on the CCO Contract Forms [webpage](#). OHA will provide the evaluation results to each CCO within 8 weeks of the submission due date.

### In preparing your submission, please note:

- The submission should clearly indicate the date the CHA/CHP documents were published (e.g. September 2020) or the date the documents are effective (e.g. 2020-2025).
- For CCOs submitting a CHA and CHP, any supplemental documentation referenced in the CHA/CHP evaluation assessment must be submitted along with the CHA/CHP and completed CHA/CHP evaluation assessment.
