NEED FOR THE RULE(S):

The OHP program administrative rules govern the Division's payments for services provided to clients. The Authority needs to temporarily amend OAR 410-141-3830. This change will reference the approved Health Evidence Review Commission (HERC) Prioritized List of Health Services, effective January 1, 2022– September 30, 2022, and incorporating interim modifications annotations. The changes will be effective January 1, 2022.

JUSTIFICATION OF TEMPORARY FILING:

The Authority finds that failure to act promptly will result in serious prejudice to the public interest, the Authority, providers and recipients of Medicaid benefits. The Division needs to amend this rule to reflect the correct changes to the Covered and Non-Covered Services, January 1, 2022, and align rule text with the designated benefit package on the Prioritized List.

RULE TITLE: Prioritized List of Health Services

RULE SUMMARY: Amend rule to reflect the updated Prioritized List of Health Services, effective January 1, 2022 to September 30, 2022.

This rule, effective January 1, 2022, incorporates by reference the January 1, 2022 Prioritized List, funded through line 472 and including all line items, diagnosis and treatment codes, guideline notes, statements of intent, coding

specifications and annotations. This Prioritized List dated January 1, 2022 supersedes the October 1, 2021 Prioritized List for services provided after January 1, 2022, and includes interim modifications reported as required under ORS 414.690(7) and (8).

RULE TEXT:

- (1) The Health Evidence Review Commission (HERC) Prioritized List of Health Services (Prioritized List) is the listing of physical and behavioral health services with "expanded definitions" of practice guidelines and statements of intent as presented to the Oregon Legislative Assembly. The Prioritized List is generated and maintained by HERC. The HERC maintains the most current list on their website: https://www.oregon.gov/OHA/HPA/DSI-HERC/Pages/Prioritized-List.aspx.
