

# **Coordinated Care Changes by County**

Facts about changes to coordinated care organizations (CCOs) effective January 1, 2020

This fact sheet summarizes the changes in each Oregon county. Enrollment numbers are rounded, provided for general context only, and reflect preliminary enrollment information as of October 15, 2019.

#### **Baker County**

No changes.

#### **Benton County**

InterCommunity Health Network (IHN) will serve this county. Trillium Community Health Plan and Willamette Valley Community Health members will move to IHN.

- Trillium serves 310 members.
- Willamette Valley Community Health serves 5 members.

## **Clackamas County**

Health Share of Oregon and Trillium will serve this county. However, Trillium cannot enroll members in this county until at least April 1, 2020. Willamette Valley Community Health and Yamhill Community Care members will move to Health Share.

- Health Share of Oregon serves 61,740 members.
- Willamette Valley Community Health serves 180 member.
- Yamhill Community Care serves 50 members.

# **Clatsop and Columbia counties**

No changes.

# **Coos County**

Advanced Health will serve this county. Trillium members will move to Advanced Health.

Trillium serves 180 members.

# **Crook, Curry and Deschutes counties**

No changes.

# **Douglas County**

Only AllCare CCO, Trillium and Umpqua Health Alliance will serve this county. PrimaryHealth of Josephine County and Advanced Health members will choose a new CCO.

- Advanced Health serves 15 members.
- PrimaryHealth serves 250 members.

# Gilliam, Grant, Harney and Hood River counties

No changes.

#### Jackson County

Only AllCare CCO and Jackson Care Connect will serve this county. PrimaryHealth members will choose a new CCO. AllCare members with a PrimeCare medical group primary care provider will move to Jackson Care Connect.

- AllCare serves 26,470 members.
- PrimaryHealth serves 1,060 members.

#### **Jefferson County**

No changes.

## **Josephine County**

Only AllCare CCO will serve this county. PrimaryHealth members will move to AllCare CCO.

• PrimaryHealth serves 9,080 members.

#### Klamath and Lake counties

No changes.

#### **Lane County**

PacificSource and Trillium will serve this county. Trillium members can choose PacificSource. Trillium members with a Peace Health or Oregon Medical Group primary care provider will move to PacificSource.

Trillium serves 88,470 members.

#### **Lincoln County**

No changes.

# **Linn County**

InterCommunity Health Network and Trillium will serve this county. Willamette Valley Community Health members will choose a new CCO.

• Willamette Valley Community Health serves 820 members.

# **Malheur County**

No changes.

# **Marion County**

PacificSource will serve this county. Willamette Valley Community Health and Yamhill Community Care members will move to PacificSource.

- WVCH serves 85.670 members.
- Yamhill Community Care serves 90 members.

## **Morrow County**

No changes.

# **Multnomah County**

Health Share of Oregon and Trillium will serve this county. However, Trillium cannot enroll members in Multnomah County until at least April 1, 2020.

Health Share of Oregon serves 172,000 members.

#### **Polk County**

PacificSource and Yamhill Community Care will serve this county. Most Willamette Valley Community Health members will move to PacificSource.

- Willamette Valley Community Health serves 15,275 members.
- Yamhill Community Care serves 1,310 members.

### **Sherman County**

No changes.

## **Tillamook County**

Only Columbia Pacific CCO will serve this county. Any Yamhill Community Care members will move to Columbia Pacific CCO.

Yamhill Community Care serves 0 members.

## Umatilla, Union, Wallowa, Wasco counties

No changes.

## **Washington County**

Health Share of Oregon and Trillium will serve this county. However, Trillium cannot enroll members in Washington County until at least April 1, 2020. Yamhill Community Care members will move to Health Share.

- Health Share of Oregon serves 85,370 members.
- Yamhill Community Care serves 1,930 members.

# Wheeler County

No changes.

# **Yamhill County**

Only Yamhill Community Care will serve this county. Willamette Valley Community Health members will move to Yamhill Community Care.

Willamette Valley Community Health serves 20 members.
