

The Oregon Health Plan covers COVID-19 and flu vaccines for children, youth, and families



Kids 5 and older can now get the COVID-19 vaccine.

Since May 2021, youth ages 12-18 have been able to get the Pfizer COVID-19 vaccine. Starting November 3, 2021, kids ages 5 through 11 will be able to get the pediatric Pfizer COVID-19 vaccine.

OHP covers the COVID-19 vaccines and the flu shot for OHP and CWM members.

The Oregon Health Plan (OHP) covers COVID-19 and flu vaccinations for OHP and CWM members. COVID-19 and flu vaccines are available through pharmacies, doctor's offices, community clinics, and hospitals.

The Oregon Health Authority strongly encourages everyone get both a COVID-19 and flu vaccine if they can.

- Children 6 months and older can get a flu shot. Parents and guardians should take children who are between 6 months and 2 years old to their child's doctor's office to get the flu vaccine.
- Youth 15 years and older do not need their parents' permission to get vaccinated.

Pharmacies can now provide children's COVID-19 and flu shots.

Parents and guardians can also take children to any pharmacy that accepts OHP or CWM coverage and is ready to provide vaccines to children.

- Children 3 and older may get the flu shot at the pharmacy.
- Children 5 and older may get the Pfizer COVID-19 vaccine at the pharmacy.

Children 5 and older can get the Pfizer COVID-19 vaccine and the flu shot at the same time. They can get these shots at the same visit, or on another day.

Members should plan ahead before taking children to get the Pfizer COVID-19 vaccine and flu shots.

Find vaccine providers who accept OHP and are ready to provide flu and COVID-19 vaccines to younger children.

- If you plan to visit a pharmacy, contact the pharmacy to make sure they have both vaccines, they can give your child the vaccines, and that they accept OHP.
- If your children have a primary care provider (PCP), ask the PCP about their vaccine options.
