Oregon Health Authority (OHA)

- At this time, no changes have been made to health programs OHA administers, including OHP and Healthier Oregon.
- It's important for people in every Oregon community to access the health care and other services they need.
- OHA remains focused on eliminating health inequities by 2030 in Oregon.
- Every change in federal administration presents possible changes to health care policy.
- OHA will continue to monitor, prepare for and inform the public about changes that could impact access to health care and public health services in Oregon.
- OHA will continue to work toward affordable and quality care, and to protect essential health freedoms and benefits. There has been and will be no move from this mission.

Healthier Oregon

- Healthier Oregon was passed into law in 2021 (Oregon House Bill 3352) and has increased access to healthcare so that people of any age or immigration status may qualify for full Oregon Health Plan (OHP) benefits.
- The mostly state-funded program remains unchanged.
- All OHP members, including those enrolled via Healthier Oregon, continue to have health care coverage and access to health benefits under these programs.
- OHA is required by law to inform members about any changes to the Healthier Oregon program in a timely manner.

General 2025 Legislative Session Information

- The Oregon Legislature will meet in January to begin discussing the state's budget for the 2025-2027 biennium.
- The timeline is:
 - December 2, 2024 Governor Tina Kotek released her <u>budget</u> <u>recommendations</u> for the 2025-2027 biennium. The Legislature will review and determine which recommended investments to pass.
 - o January 21, 2025 The Legislative session is scheduled to begin.
 - June 28, 2025 The Legislative session is scheduled to end.

Public Charge

When people want to get legal status to enter or stay in the U.S., immigration
officials consider if they are likely to need economic help from the government.
This is called the "public charge test." Non-cash benefits aren't counted in the
public charge test including Medicaid, Supplemental Nutrition Assistance

- Program (SNAP) and vaccines, however it's important to understand how accessing benefits could impact your immigration case.

Misinformation

- Integrity and transparency are two of OHA's guiding values as we strive to ensure all people can achieve optimum physical, mental and social well-being.
- OHA is committed to providing accurate and timely information that empowers people as they make important health decisions.
- With so much information being shared across multiple platforms, it's important to know the difference between factual, evidence-based health information and misinformation online.
- Consider the source. Here are five questions you can ask yourself to help distinguish between true and false information:
 - o Is the author credible enough to speak to the topic?
 - o Is the author or news source biased?
 - Open Does the author cite their sources?
 - o Is this a well-known or legitimate website?
 - o Is this account or website devoted to satire or parody?
- Read more than just the headline.
- Check the date when the information was published.
- Analyze the content to look for pieces of information that are inconsistent with others that you have read or seen, or seem overblown, dramatic or lacking specific evidence.
- Conduct a reverse image search If you suspect a photo is fake.
