

Community Listening Sessions for Oregon Health Plan (OHP) Members with Open Card Coverage

Share your thoughts about care coordination

The Oregon Health Authority (OHA) wants to hear from people with lived experience with OHP open card (fee-for-service) coverage. This feedback will help OHA draft rules that reflect the needs of OHP members and guide how health care partners coordinate member care.

Who can attend?

These sessions are for:

- Current or past OHP open card members,
- Family members of OHP members,
- People who help OHP members. This could include ombudspersons, Court Appointed Special Advocates (CASA), other court appointed guardians, community partners and other advocates,
- Providers who offer services to OHP open card members, and
- Contractors who provide care coordination support for OHP open card members.

What will happen during the listening session?

OHA will share general information about:

- What care coordination means
- How care coordination helps people get the type of care they need when they need it, and how they need it.
- How the state makes and updates rules.

OHA staff will guide conversation around these questions:

- Your health care providers should work together to keep you healthy. Is this important to you? If so, why?
- Share a time when you felt your doctors worked well together. What made things work well?
- Share a time when you felt your providers did not work well together or arrange the care you needed. What happened? How could that have worked better?
