

Healthier Oregon Desk Reference Manual

This document explains the claim details for the Emergency Health Benefits Funding portion of the Healthier Oregon benefit.

Behavioral health crisis treatment services

For services provided on or after January 1, 2022 Crisis services provided as detailed below are emergencies:

- Professional claims must pair a behavioral health diagnosis code from Group 6179, and a CPT crisis code 90839 or 90840.
- Inpatient and outpatient claims must pair a behavioral health diagnosis code from Group 6179 and an emergency admit type 1.

Dialysis treatment

For **outpatient services** provided on or after January 1, 2022. Outpatient dialysis services provided as detailed below is an emergency. No emergency indicator is required.

- Claims must include a dialysis diagnosis code from [Group 6014](#) in the header and
- Codes billed by provider type/specialty 32/200.

For **inpatient and emergency dialysis treatment services** provided on or after July 1, 2022:

- Claims must include a dialysis diagnosis code from [Group 6014](#) on the admit and/or final diagnosis and admit type 1.

Cancer treatment

For emergency services provided on or after January 1, 2022:

- Claims must include a diagnosis code from Group 6186.
- No emergency indicator is required (the cancer diagnosis is the emergency).

Treatment includes:

- Radiation therapy
- Services or medications to treat side effects, co-morbid conditions and complications of cancer treatment that if left untreated would place the patient's health in serious jeopardy, cause serious impairment to bodily functions or serious dysfunction to any bodily organ or part;
 - Billing for these services may require an emergency indicator.
- Surgery
- Lab tests and radiology to measure and track treatment
- Oncology office visits
- Inpatient treatment and recovery

COVID 19 treatment

For emergency services provided until May 11, 2024:

- Claims with a COVID-19 diagnosis from Group 6104 with an emergency indicator or admit type

- Claims with a COVID-19 diagnosis from [Group 6149](#) without an emergency indicator.

Other emergency claims

- Inpatient and outpatient institutional claims must include a [Group 6014](#) diagnosis code in the admit or primary position and the admit type 1.
- Professional claims must include a [Group 6014](#) diagnosis code in position 1-4 and the emergency indicator Yes.

Emergency Ground and Air Medical Transportation:

When billed with procedure codes A0225, A0424, A0425, A0427, A0429, A0430, A0431, A0433, A0434, A0998.

Pending Changes

The Authority is working on system changes to support emergency match for immunosuppressant office visits, labs and medications for the Healthier Oregon program. These benefits were not included for the capitation rate year 2023.

The Authority is working on system changes to support emergency match and rebate for all emergency medications. Medications for emergency services defined in this manual (except for cancer treatment) were not included for the capitation rate year 2023.

The Authority is working on a system change to allow Healthier Oregon members who have Medicare to enroll in CCO's. Until 2025, Healthier Oregon members with Medicare will receive case management through Acentra Healthcare and access to the OHP Open Card provider network. Medicare is the primary and OHP is the secondary insurer.
