

Oregon Health Plan reimbursement for diabetes self-management programs

This fact sheet explains covered diabetes self-management programs and how Oregon Health Plan (OHP) clinics, hospitals, federally qualified health centers, health departments and tribal health centers may provide and bill for services provided through these programs.

Stanford Diabetes Chronic Disease Self-Management Program for Diabetes (CDSMP)

Also known as the Diabetes Self-Management Program (DSMP), this program is for all OHP members with Type I or Type II diabetes.

- This program is available in Chinese, and in Spanish as *Manejo Personal de la Diabetes*.
- These programs are taught by a trained instructor who can be supervised by a medical professional.
- The clinic's lead providers may supervise and bill for trained CDSMP instructors.

Diabetes Self-Management Training (DSMT)

Also known as Diabetes Self-Management Education and Support, these programs must be recognized or accredited by the American Diabetes Association (ADA) and the American Association of Diabetic Educators (AADE), the two nationally approved DSMT accreditation organizations.

Only trained Registered Dietitians and AADE-accredited nurses may provide DSMT training. [Learn more on the CDC website](#).

To bill for covered services:

Bill the member's coordinated care organization (CCO). If the member is not in a CCO, bill OHA.

- Telehealth billing after 9/20/2023: Use modifier 95 and include Place of Service code 02 when the client or member is located in a place other than their home or Place of Service code 10 when the client or member is located in their home.
