§Fillings are covered at 100% for amalgam fillings on back teeth and composite tooth color fillings on front (smile line) teeth. Patients can request composite fillings for back teeth and pay additional fees. Contact Kaiser Permanente directly for fee information.

¶Benefit is subject to a 12-month benefit waiting period for late enrollees.

Now, let's talk about the Kaiser Permanente dental plan.

There is no deductible for our Kaiser Permanente dental plan. Each time you come in, you will pay a \$20 office visit copay. This copay will cover the cost of most basic services, but you will have some additional cost on restorative and major services such as root canals, crowns and bridges, implants, and orthodontic treatment.

There are no plan changes for the plan beginning October 1, 2020.
