WHAT COMMUNITY HEALTH WORKERS DO

A Community Health Worker (CHW) is a frontline public health worker who is a trusted member of and/or has a close understanding of the community served. This trusting relationship enables the CHW to serve as a liaison/link/intermediary between health/social services and the community.

- Work in health departments, medical clinics, and social service agencies
- Home visits
- Patient education
- Community Advocacy
- Case Management - assist patients with accessing community resources

After successful completion of this 120-hour training, approved by the Oregon Health Authority, students may become **certified by the state of Oregon as a Community Health Worker**. In Oregon, CHWs are eligible for Medicaid reimbursement.

HHP 299 COMMUNITY HEALTH WORKER 6 CREDITS

Class Schedule:

- Course offered fall term 2021
- Course length: 11 weeks
- Hybrid class:
 - Students will meet on the Redmond campus for in-person classes for 6 Fridays during the term (12pm to 5pm): 9/24; 10/8; 10/29; 11/5; 11/19; 12/3
 - Students will engage in weekly online learning modules

To register for the course:

- Must complete COCC admissions process before registration: Priority registration for class (first come, first-served).
- There are no academic pre-requisites for the course.
- Students need to have reliable access to the internet and a computer (computer labs are available for student use on all COCC campuses)
- A high school diploma or GED are not required to receive the training. They may be a requirement from the potential employer.

Oregon Health Authority Certification Requirements:

- Completion of the *OHA-approved* COCC CHW training course
- Must be 18 years old
- Criminal background check required
- Government issued identification required (state IDs, Driver License, or passport)
- Certification is valid for 3 years. To renew certification, 20 hours of continuing education is required.

TUITION*

- **HHP 299 Community Health Worker class:** approximately \$755 (scholarships available)
- **Textbook:** no textbook costs
- **Certification:** no cost

**Assumes in-district tuition. Tuition is an estimate and subject to change.*

COURSE SCHOLARSHIPS
