- Bill Oregon Health Authority (OHA) for carve-out drugs for coordinated care
 organization (CCO) members, drugs for fee-for-service (FFS or "open card") members,
 drugs not covered by Medicare Part D, and drugs not included in the long-term care
 facility's bundled rate.
- **Bill Moda Health** for dental prescriptions for members with OHP Dental (COFA Dental or Veteran Dental) benefits.
- Bill the CCO for all drugs, minus the carve-out drugs, for other CCO members.

After these limits expire, adjust paid claims and rebill denied claims on paper.
