

Dear Mr. Campbell:

I am pleased to provide this letter of support on behalf of GOBHI and affiliated partners in the CCO 2.0 procurement application being made to Oregon Health Authority. Our organization has had a long-standing contractual relationship with GOBHI to provide a sub-acute, crisis psychiatric level of care to OHP/Medicaid member youth covered under the agreement. Because of this partnership, in the past 12 months alone Kerr has provided over 500 service days to kids experiencing an urgent mental health crisis requiring a safe and secure, short-term residential placement with 24-hour access to mental health professionals.

Our consistent experience has been that GOBHI understands our service model very well. Our sub-acute program is the only standalone facility of its type in Oregon, and GOBHI representatives have personally met with us to tour our facility, which I can say is atypical of most payers we work with. They recognize the value that our service provides to members, both in terms of outcomes and cost, as kids are most often able to transition to a less intense level of mental health care following their short-term stay in our program. Because of this understanding, GOBHI has worked well with us in negotiating a fair rate structure that will help to ensure that this service can be sustained into the future.

Based on this positive partnership over the years, we again affirm our support for GOBHI, along with its partners, in NWCCO's procurement application to OHA for the Clatsop, Columbia and Tillamook County service areas.

To whom it may concern,

I am writing to express some of my experience over nearly a decade of working with GOBHI on the Consumer Caucus and other committees inside of GOBHI.

In 2010 I had just been diagnosed with a mental disorder. I was unemployed, confused, very disillusioned with my life, and had no idea how I would live from that point on. A clinician at Wallowa Valley Center for Wellness suggested I go to a Peer Support training, sponsored by GOBHI. It changed my life because it introduced me to a new way of looking at my life and disability, and helped make sense of many of the troubles I had found myself in over the years of living with an undiagnosed problem. It also showed me how I could be of service in the world going forward.

I was invited to contribute to GOBHI committees by attending and providing input based on my lived experience. I was like a fish out of water at first, but the folks on staff and clinicians and clinical directors helped me learn and get up to speed. They treated me like a valued member of a team. They always interacted with me in a way that showed how deeply interested they were in my success working with the committees.

Over the years, as I spent more time on the committees and then as a member of the Consumer Caucus I met most of the management folks at GOBHI. I greatly appreciated the kind way in which they made me feel a part of things, asked how I felt about what I saw going on, and asked for my input both formally and informally about programs and guidelines. I was always treated like a member of the group, never looked down at or regarded oddly in any way. I learned they truly cared about me as a member of a kind of extended family, and were very supportive as I recovered.

GOBHI has always had a unique culture dedicated to involvement of consumers no matter how large it has become over the years. What has impressed me the most is the consistent integrity of their interactions with all parties. I have heard a lot of rhetoric over the years from individuals and organizations who claim to be "client centered" or "trauma informed". GOBHI folks at all levels have acted just as they speak by wholeheartedly supporting client-centered initiatives such as Dual Diagnosis Anonymous, the David Romprey Warmline, Senior Warmline, and countless peer delivered service trainings over the years. For many years they have sent a contingent of GOBHI peer service leaders to the Alternatives conference to acquire skills and bring them back to their home agencies and counties. They believed deeply in my potential and were instrumental in my success as a provider with lived experience.

As a result of the invaluable help and support I received from the kind folks at GOBHI I have advanced and excelled in my work. I am now a Certified Recovery Mentor, Peer Support Specialist, and QMHA at an agency in NW Oregon, and have been involved in this work for nearly 10 years now. I love helping people and learned much about how to do that through my experiences with GOBHI.

I am happy to express my hope that GOBHI and its unique way of helping people can be brought to a wider part of the Oregon mental health community.

Dear Ms. Hurst:

I am retired from a 40-year career working in mental health and addiction service agencies within Oregon, including in Washington, Multnomah, and Clatsop counties. Within those years, and especially as an executive director, I learned much about what works and what doesn't, and which organizations have the most expertise and competence in managing provider agencies, and in being a true community partner.

For decades, I have worked directly and indirectly with Greater Oregon Behavioral Health, Inc. (GOBHI) and their partnership with Moda to form and administer the Eastern Oregon CCO (EOCCO). I have seen how they respect and adapt to county differences and individual county dynamics and providers of these services. In my experience, there is no more competent and ethically driven organizational partnership and huge success than what is widely experienced and known about the EOCCO. The leadership in these two organizations in the most rural counties of Oregon, primarily Kevin Campbell and his teams, far exceeds any other I have had direct and indirect contact with elsewhere in Oregon.

As a GOBHI board member from Clatsop County for six years (and also as a community leader and exec in Multnomah and Washington county agencies since 1982), I have seen how these two organizations operate together within their assigned counties, and I have seen firsthand the success in service provision and with county relationships by these organizations.

In my work through the years in the three Oregon counties, I grew to understand the true differences between rural and urban county populations and service delivery systems. GOBHI and Moda have worked tirelessly and with great achievement in rural Oregon counties. Their expertise and reputation in these rural counties has been shown by the variety of service models and programs they have already helped set up for vulnerable populations there. These two organizations are already well known and highly respected by county leadership and partners throughout rural communities. In my opinion, there will be NO WAY to equal or exceed this if an organization other than NWCCO is chosen to operate in the leadership role within northwest Oregon. NO WAY.

In my opinion, Clatsop, Columbia, and Tillamook counties have been operating with progress and success for a very long time under the leadership of GOBHI as a MHO and as a risk-bearing partner in Columbia Pacific CCO. By sponsoring the formation of the NWCCO, GOBHI is once again demonstrating its leadership and understanding of rural Oregon by bringing a community based approach and proven partnerships forward for consideration in CCO 2.0 and beyond. These organizations have already proven their ability to involve the communities in decision-making and in what is needed and why, and they have contributed large sums of money and countless hours in successful consultation with consumers and professionals involved in system-building there. The State would be foolish to not allow the expansion of this successful model from 12 counties to 15. And, frankly, in my lengthy experience in Oregon, the State cannot afford to lose even one bit of credibility in these issues and decision-making.

I would be happy to go into more detail about my experience and opinion in this matter, if desired by the selection team. I have worked closely with the State in this system for decades, and have experienced and understood how the relationship between the state and county leadership must be coherent and cohesive in order to achieve the highest level of service to our fragile citizens and consumers. In these rural counties, it is imperative that GOBHI and Moda maintain their current leadership and success and potential for future development. There would be no other logical and responsible choice for Clatsop, Columbia, and Tillamook Counties than NWCCO.
