

Umpqua Health Alliance Support Letter

Mental illness often carries stigma and shame and the fear of being negatively judged. Those who live with mental illness can struggle with isolation and find difficulty in seeking help. Here in Douglas County, chronic mental health issues like depression impact over a quarter of all adult residents. Depression among youth has also steadily increased. Suicide rates in Douglas County are among the highest in Oregon. Umpqua Health Alliance (UHA), as Douglas County's Coordinated Care Organization serving Oregon Health Plan members, has expanded much needed mental health counseling services and programs. Today, thanks to UHA, individuals and families living throughout Douglas County have greater accesses to the critical care and support needed to manage and recover from mental illness.

UHA, in particular, has provided funding to open a new behavioral health services center, the Chadwick Clubhouse, in Roseburg, operated by the Douglas County Chapter of the National Alliance on Mental Illness. The Clubhouse provides psychosocial rehabilitation services on a day treatment basis for up to 10-15 members a day, who are learning to manage serious chronic mental illness and return to daily life activities. The Clubhouse is staffed by a manager that oversees onsite operations that include ongoing life skills training, educational needs, housing assistance, rehabilitation, wellness and social support activities. There are also plans to add transitional job placement services this year to aid Clubhouse members in returning to work in part-time or full-time positions.

Over the last five years, UHA has served as an active community partner in helping raise greater awareness about mental illness as a major issue impacting so many individuals and families in Douglas County. UHA's local involvement has greatly enriched and expanded our community-based programs that give hope and provide a road to recovery for those who otherwise generally struggle in isolation. We fully support UHA's application to the Oregon Health Authority to continue serving as Douglas County's Coordinated Care Organization.


Umpqua Health has also demonstrated competent leadership and investment in behavioral health providers by hosting regular provider luncheons where training, education and coordination occur.



I have been a local Mental Health provider in Douglas County for the past 8 years. I worked 5 of those years in an agency setting serving the OHP population and the last 3 years as a Private Practice Provider. My case load now consists of about 40% OHP and 60% other insurers. Over the past five years, I have been excited about the potential for local CCO's to create a more seamless continuum of care for the OHP population across various disciplines and agencies. Umpqua Health Alliance (UHA) has endeavored to bring quality care to OHP patients through improving outcomes, reducing barriers to access, and developing a more holistic approach to wellness through creating and implementing local community-based programs for the common good.

When I was in an agency setting, it was often a challenge for one agency to be solely responsible to provide all the resources and services needed for our OHP population. UHA's efforts over the past 5 years to expand service accessibility beyond a single agency entity by creating a panel of licensed community mental health providers, as well as expanding mental health care into local health clinics has greatly improved people's access to care and given them more of a say in their healthcare services.



I am pleased to support the UHA in its application to remain the CCO serving Douglas county. As a specialist clinic (neuropsychology), we find it challenging to serve the needs of our communities in part because insurers and related entities do not have an accurate grasp of the services we offer, the codes we have to use, and the ways that our practice is different from standard psychological practice. As a neuropsychological clinic, we offer diagnostic assessment to assist in the diagnosis of conditions such as dementia, head injury, multiple sclerosis, Parkinson's, etc., with the goal of helping these patients with accurate identification of their conditions and with recommendations for management. The UHA has spent time and focused energy to better understand the process of neuropsychological assessment and has worked with our billing manager to simplify the preauthorization process. I have practiced medicine in Douglas County since 1991, essentially for 28 years and still very much committed to serving this community for many more years.

In my specialty of anesthesia, I serve young OHP patients who are having tonsillectomies to senior OHP who are very ill. I also serve as Medical Director and Clinical Administrator for the Surgical Services Department of Mercy Medical Center. The Douglas County OHP program has provided access to much needed medical care to this at risk patient population.

In my experience, Umpqua Health Alliance has successfully managed the coordination of care by addressing disease management, nurse follow-up after discharge from a hospitalization or emergency room, socioeconomic barriers to achieving a healthcare goal. Umpqua Health Alliance has sponsored many community programs such as Smoking Cessation, Smoking Cessation before elective major surgery, Colon Cancer Screening, Vaccinations and Dental Care. For example now all patients, whether OHP or with any other health insurances, will have stopped smoking for at least 30 days prior to elective scheduled total joint replacement. This has resulted in a significant reduction in infections after this type of surgery.

I strongly support Umpqua Health Alliance's application to serve as Douglas County's CCO. They have produced results and will continue to positively serve Douglas County's OHP population.

Dear Ms. Hurst:

Battered Persons' Advocacy (BPA) is the only victim services agency in Douglas County that provides 24/7 access to services for survivors of family violence, sexual assault, stalking and human trafficking. BPA advocates have developed relationships with UHA providers, made referrals to UHA clinics and membership services, and have accompanied patients to appointments since 2012. We have been impressed with the access to integrated physical and mental health services within UHA Clinics – I have personally witnessed this coordination of care and responsive approach save lives. I also have been a proud member of the UHA Community Advisory Council since 2012. In my role I feel that I have been able to share the perspectives and experiences of the most vulnerable populations of our community. I have felt that my voice has been heard and UHA is meeting the community's needs, non-emergent transportation is just one example.

It is increasingly recognized that intimate partner violence can result in serious, and often long-term, effects that are costly for both the individual and the healthcare system. In 2013, our organization along with community partners like UHA supported the Safer Futures Project which still exists and thrives today. The program is designed to improve the health and well-being of mothers and their new born after intimate partner violence has occurred through the intervention of a trained, certified advocate. Because many social determinants of health are outside the institutional healthcare system, the strategy for improving health requires that work be done in collaboration with non-profit sectors like BPA. The Safer Futures Program is able to provide in areas such as increasing income, legal support, accessing housing, food, clothing, providing transportation, and offering educational support groups. UHA has provided significant financial investment to sustain and measure the success of this program. UHA's funding has also served as a match for over \$300,000 to hire an additional 2 Healthcare Advocates, who function much like Community Health Workers.

In 2016-17, UHA supported Phase I & II of the Creating Community Resilience Collaborative project. Efforts increased foundational awareness and knowledge related to Adverse Childhood Experiences (ACEs) and the impact on health across the lifespan. The project included training over 700 healthcare and early childhood professionals. Phase II was to improve social and clinical determinants of health and healthcare outcomes by integrating Adverse Childhood Experiences (ACEs) science and assisting three organizations across sectors in becoming trauma informed organizations. Cow Creek Health & Wellness, Phoenix Charter School and BPA have begun the implementation of The Sanctuary® Model, a blueprint for organizational, clinical, or community change which at its core, promotes safety and recovery from adversity through the active creation of a trauma-responsive community. With the support of UHA and the Community Advisory Council the Creating Community Resilience (CCR) Initiative has continued community training efforts including hosting Dr. Ken Ginsberg, giving over 400 professionals the tools to better reach teens and build on community partnerships. UHA has been open to community involvement which has provided CCR's members and many other community members to provide input into the Community Health Assessment and Community Health Improvement Plan processes.

We urge you to give UHA's 2.0 proposal your full consideration. Please feel free to reach out to me if you have questions or would like additional information.



The South-Central Early Learning Hub appreciates Umpqua Health's coordinator for New Day and New Beginnings joining the Hub's Community Uplift partners to use the closed loop information and referral system including the Hub's Family Resource Facilitators and database. It would also be beneficial to children and families for the Hub to work with Umpqua Alliance to brainstorm solutions with medical providers for behavioral and health issues for Preschool Promise and other early childhood providers in Douglas County. We all are committed to focusing on the social determinants of health.

Umpqua Health has appointed medical representatives (decision makers with medical expertise) to the Douglas Community Governance Council in the past. Unfortunately, because of organizational changes at Umpqua Health, the Hub's Douglas Community Governance Council currently does not have a representative on the Douglas Community Governance Council after having three different representatives (decision makers with medical expertise) from Umpqua Health for short intervals of time. The Hub hopes with the initiation of CCO 2.0, that we can successfully collaborate with Umpqua Health as we have with Cascade Health Alliance (CHA) partnership to ultimately meet the mutual Early Learning Hubs/CCOs goals.

In the last year, the Oregon Early Learning Council worked closely with the Oregon Health Authority, Early Learning Hubs and other partners to create the "Raise Up Oregon: A Statewide Early Learning System Plan for 2019-2023," including strategies and goals that align with CCO 2.0 and Early Learning Hubs. A few examples of the multiple shared system goals and strategies are on pages 13 and 18 of the Plan:

System Goal 1: Children arrive ready for kindergarten:

Objective 4: Early childhood physical and social-emotional health promotion and prevention is increased (page 13).

Strategy 4.1 Ensure prenatal-to-age-five health care services are comprehensive, accessible, high quality, and culturally and linguistically responsive.

Improve access to patient-centered primary care homes for all young children.

Strengthen the early childhood focus of Coordinated Care Organizations (CCOs) by adding Early Learning Hub representation on CCOs' governing boards or using other tools to improve relationships and coordination.

Increase the integration of physical, behavioral and oral health for young children.

Incentivize high-quality, evidence-based pediatric care, including rural communities.

System Goal 2: Children are raised in healthy, stable, and attached families:

Objective 8: All families with infants have opportunities for connection (page 18).

Strategy 8.1 Create a universal connection point for families with newborns.

Build, in partnership with local communities, Early Learning Hubs, Coordinated Care Organizations, and public health agencies, a system to deliver home visits for all families with newborn children that provides parenting information and helps families with deeper needs connect to additional services.

The Hub's goal is to begin the conversation with Umpqua Health's medical partners as to how we can actively and effectively work together to successfully reach our mutual System Goals, Objectives and Strategies for the benefit of healthy, stable and attached families with an aligned and coordinated system to assure that children are prepared to enter Kindergarten with the skills they need to be successful.

A well-balanced, healthy diet is all-important for good health. Many preventable chronic diseases, such as type 2 diabetes, heart failure, and obesity, can be tied, in part, to poor diet and nutrition. Rates of type 2 diabetes and obesity in Douglas County are among the highest in Oregon. The Umpqua Community Veg Education Group (UC-VEG) is a grassroots non-profit organization working in Douglas County to promote healthy food choices that incorporate more nutritious whole, plant-based foods. Umpqua Health Alliance (UHA) for the last three years has provided critical funds to operate UC-VEG's highly-successful Total Health Improvement Program (THIP), which is open to UHA's Oregon Health Plan members.

THIP is a 12 week evidence-based, disease prevention and reversal series that uses lifestyle medicine to help individuals learn about nutrition and plant-based cooking. Around 1,000 people have gone through the program in the last three years and have seen profound results such as significant weight loss, lower cholesterol, lower blood pressure, improved mood, and greater energy. Health improvements are verifiable through pre and post blood draws and regular weight measurement. About 85 percent of participants lost weight through THIP and about 35 percent experienced a drop of 20 or more points in their cholesterol.

UHA is helping transform community health in Douglas County by making community-based programs possible like the UC-VEG Total Health Improvement Program. UHA serves as a catalyst for local organizations like ours to take on challenging issues like poor lifestyle choices that impact health. We ask the Oregon Health Authority to select UHA to continuing serving as Douglas County's Coordinated Care Organization.

Adapt has been a provider of healthcare services to indigent, working poor and OHP members in Douglas County for nearly 50 years. Umpqua Health Alliance (UHA) has been a critical partner in the development of integrated addictions, mental health, and primary care services. Founded in 1971 as an outpatient alcohol and drug abuse treatment program, Adapt now provides OHP members with a full continuum of substance use disorder treatment including outpatient, residential, Opioid Treatment Program (OTP), medication assisted treatment for alcohol and opioid use disorders, inpatient and outpatient corrections and drug court services, and sober supported housing. Prevention and treatment services are offered to both youth and adults. UHA has been a key collaborator in the development and continued operation of these services.

In 2006, with the support and assistance of UHA, Adapt dba SouthRiver Community Health Center (SRCHC) began providing primary care services. SRCHC is now a Federally Qualified Community Healthcare Center (FQHC). UHA has been a critical partner in the development of SouthRiver into a Patient Centered Primary Care Home (PCPCH) with integrated care including behavioral medicine, medication assisted treatment for addictions, and mental health services. For example, most recently UHA supported Adapts efforts to reverse engineer primary care into the outpatient addictions and Community Mental Health Program (CMHP) at 621 W. Madrone St. This clinic which opened in April of 2019 is designed to engage members with addictions and severe and persistent mental illness (SPMI) in a PCPCH that is located in a 70,000 sq. ft. outpatient addictions and mental health treatment facility which is fully integrated with the CMHP.

In 2014 Douglas County decided to stop being the Local Mental Health Authority (LMHA) and the CMHP for Douglas County. This was placed on a fast track and in just 90 days UHA collaborating with several community stakeholders stood up a non-profit to assume the CMHP responsibilities. These heroic efforts were made to avoid plunging Douglas County into a mental health services crisis. The new non-profit, Community Health Alliance, ultimately failed and those responsibilities and services were assumed by Adapt in 2016. Adapt, dba Compass Behavioral Health, became both the LMHA and the CMHP for Douglas County. UHA provided substantial support during both of these transitions and in the rebuilding process that has taken place since 2016. Some examples of the success of this collaboration include; doubling the annual number of CMHP services to adults and tripling for youth and families; CMHP providing services onsite in 23 schools; CMHP now operating three therapeutic learning classrooms (TLC) in southern, central and northern Douglas County.

Adapt has seen firsthand the critical role UHA plays in the delivery of quality medical care to its members. We have been extremely pleased to be included in almost every aspect of UHA from its original development as a Coordinated Care Organization (CCO). As described above UHA has been a critical partner in addressing the healthcare needs of our community, particularly those affected by addictions and mental health disorders. UHA leadership has built a strong team with the expertise, experience, and vision to ensure they continue to serve our community as a successful Coordinated Care Organization. We fully support their CCO 2.0 application and look forward to continuing our work with this innovative organization.
