#### **Quarter 2 2024 Committee Update:**

On April 2, OHPB approved membership modifications to change the Health Plan Quality Metrics Committee chairperson to Metrics and Scoring Committee chairperson. The Behavioral Health Committee (BHC) welcomed six (6) new voting members and one (1) non-voting member appointed by OHA Director, Dr. Sejal Hathi.

New members were offered a variety of dates and times to select their choice of onboarding and training sessions. The onboarding session served as an orientation to introduce the work of OHPB, the Health Equity definition, and the Behavioral Health Division's vision, mission, and goals. They expanded their knowledge of the work of BHC, House Bill 2086, and its charge. They also learned about BHC's voting and nonvoting membership, quorums, and votes, public meetings information, time commitment, key responsibilities, and financial compensation. In addition, they were briefly introduced to the stages of metric development. Lastly, a committee timeline history and Workday account set-up instructions were provided. The training sessions were provided to assist with setting up their Workday account, complete their required trainings, set-up their one-on-one check in with Mireya Williams, Behavioral Health Metrics and Committee Manager, or ask any questions they may have.

BHC meetings resumed on Monday, June 17 at 10:05 to 11:55 am.

### **Upcoming Committee Work and Decisions:**

- Members will continue to build rapport through one-on-one connection and community building.
- Knowledge base learning on County Financial Assistance Agreements and Metrics and Scoring Committee purpose, role and goals.

BHC continues to focus on key areas related to Social Determinants of Health (SDOH) which all relate to addressing the needs of individuals who are overlooked by the current SDOH screening and referrals process employed by providers.

- Reaching individuals who have had recent contact with the justice system and/or the state hospital.
- Following up with individuals who miss physical or behavioral health appointments.
- Outreach to those not being served by Coordinated Care Organizations (CCO) for screenings.
- Follow up with individuals referred to health related social needs services regarding successful connection.

BHC has a SDOH Screening Metric Concept it is discussing further regarding increased support for individuals with high social risk-factors in receiving social needs services. Specific details of the concept must be discussed further and agreed upon to move forward with this concept.

#### Metrics:

BHC is charged with establishing:

- Quality metrics for behavioral health services provided by CCOs, health care providers, counties, and other government entities; and
- Incentives to improve the quality of behavioral health services.

#### Behavioral Health:

The quality metrics and incentives determined by the BHC will address and expand on the following areas of priority:

- Improve timely access to behavioral health care,
- Reduce hospitalizations,
- Reduce overdoses,
- Improve the integration of physical and behavioral health care, and
- Ensure individuals are supported in the least restrictive environment that meets their behavioral health needs.

#### **CCO Procurement:**

The quality metrics and incentives determined by BHC will have an impact on CCO procurement in addition to other contracts.

### **Quarter 2 2024 Committee Update:**

The Health Care Workforce Committee (HCWF) activity included:

- Adopted a new committee charter, which was reviewed and approved by the committee on April 10 and OHPB on May 7.
- Held May 8 committee meeting; topics and speakers included a 2024 Legislative Review by OHA Government Relations Team, An Overview of the Evaluation of Health Care Provider Incentive Programs in Oregon for 2025 by OHA staff Jill Boyd and Kim Tolchinsky, and a Health Care Workforce Diversity presentation by Dr. Bianca Frogner, Director of University of Washington Center for Health Workforce Studies.
- Held June 12 educational webinar, "Job Growth in Health Care and Future Workforce Needs,"
   by Jason Payton and Gail Krumenauer, Oregon Employment Department.

In April, Rebecca Donell joined the team supporting the committee on a six-month job rotation as the Primary Care Office Policy Lead.

### **Upcoming Committee Work and Decisions:**

Major work and decisions anticipated in 2024:

- Work and presentation around committee priority areas:
  - Workforce wellness
  - Workforce diversity
  - Workforce development and retention
- Continue to convene committee educational webinars on priority areas and other topics of interest
- Review of 2024 Diversity of Oregon's Health Care Workforce Report
- Review and approval of 2025 Evaluation of Health Care Provider Incentives

It's a challenge to answer which work is related to specific OHPB priorities. Work around health care professional wellness should have a positive effect around affordability, potentially CCO procurement, and behavioral health. Review of the 2025 Health Care Workforce Needs Assessment touches on all the areas. Not all HCWF's work may directly impact every one of OHPB's priorities, HCWF is aligning its activity and focus with the adopted strategic framework – but HCWF leadership sees nearly all its

discussions and projects have connections and supports for OHPB priorities. Some related presentations are mentioned below.

#### Affordability:

OHA and Oregon Clinical and Translational Research Institute (OCTRI) staff will present on a report to be released in Summer 2024 that summarizes key informant interviews on the administrative processes and policies deterring dental providers from accepting Oregon Health Plan (OHP) patients. The presentation is being confirmed for an upcoming committee meeting.

#### **Behavioral Health:**

OHA Behavioral Workforce Initiative will share a draft initial behavioral health workforce report required by House Bill 2235 (2023) at the November 6 committee meeting for input. The initial report to the Oregon Legislature is due January 15, 2025.

#### **CCO Procurement:**

OHA Medicaid Division will present on CCO network adequacy standards at the September 11 HCWF meeting.

### **Upcoming recruitment needs:**

We do not anticipate recruitment needs until Fall 2024. A focus of future recruitment will include identifying a student-in-training to provide their real-time experiences.

#### **Quarter 2 2024 Committee Update:**

The Health Equity Committee (HEC) presented its 2024 strategic workplan and letters at the April OHPB meeting. OHPB is now preparing its own statement of support and action recommendations, with input from HEC, to share publicly with OHA and statewide leadership.

HEC completed a spring round of recruitment, adding four (4) new members who completed onboarding and joined the June hybrid HEC meeting.

HEC made progress on the following 2024 strategic goals in Q2:

#### • Developing a collaboration plan with other OHPB committees

- HEC is currently working with the Public Health Advisory Board (PHAB) to build a collaboration plan that includes improved public engagement opportunities and a health equity framework that includes an antiracist approach.
- HEC is consulting with the Metrics and Scoring Committee (M&SC) to support both community engagement strategies for future health equity metrics work and in supporting Senate Bill 966, the study of the CCO Quality Metrics Incentive Program.

#### Collaborate with Government Relations on Policy Consultation Strategy

 HEC is working with OHA staff representatives from multiple teams, including Government Relations, Health Policy & Analytics, and Equity & Inclusion divisions, who lead OHA's Gender Affirming Care Workgroup as it moves from implementation of HB 2002 to developing wider policy recommendations related to health equity for LGTBQIA2S+ communities.

#### • Improved Committee Engagement

- HEC implemented members' requests for more relational opportunities in meeting and committee structure.
- HEC members approved an additional tool for consensus-based proposal review and decision-making in meetings, the "Fist-to-Five" model.

### **Upcoming Committee Work and Decisions:**

HEC will focus on the following 2024 strategic goals in 2024 Q3:

#### Compile an equity toolkit

 HEC will be working with OHA staff to review and provide feedback on proposed health equity tools (e.g. Health Equity Impact Assessment, Intersectional Gaps Analysis, and Community Engagement Framework) and implementation plans.

#### Community-Based Policy Advocacy

 HEC will follow up on the policy recommendations in its community-based policy advocacy letters on gender affirming care and Ombuds Program Support, especially those advanced in OHPB's letter to OHA leadership.

#### • Governor's Office and Director's Office Presentations at HEC

 HEC anticipates presentations from the OHA director's office on the OHA strategic plan in Q3 2024.

#### Metrics:

HEC is consulting with M&SC to support both community engagement strategies for future health equity metrics work and in supporting the SB 966 study of the CCO Quality Metrics Incentive Program.

#### **Behavioral Health:**

HEC plans to play an accountability role in tracking Behavioral Health-related recommendations from the 2022 – 2023 Ombuds Year-End reports, as highlighted in HEC's Ombuds letter of support.

#### **CCO Procurement:**

As conversations on CCO procurement advance, OHPB may engage HEC in reviewing proposed changes for equity impacts and in making recommendations for incorporating previous recommendations from HEC, OHPB committees, and community partners.

### Support or guidance needs:

HEC would benefit from continued support in aligning strategic goals and objectives across OHPB, OHPB committees, and OHA as HEC continues its work in its collaboration focus area. HEC members request a visual aid or guide to show alignment across these various strategic plans and to ensure that work is not duplicative and resources are shared when possible.

### **Quarter 2 2024 Committee Update:**

- HITOC presented an annual update to OHPB during the May 7 meeting, asking for support for Oregon's Strategic Plan for Health Information Technology 2024-2028 and approval for new membership.
- OHPB voted to support the plan, so now partners across the Oregon health IT landscape can use
  the plan to guide their work. Before the May 7 meeting, HITOC provided an educational webinar to
  OHPB members with more detail on the health IT strategic plan.
- OHPB approved the slate of new and renewing members, and then HITOC members welcomed six (6) new members to the council at their June meeting:
  - o Brian Wetter, Vice President IT Infrastructure & Analytics at PacificSource
  - Jennifer Chi, Director, Digital Experience at CareOregon
  - o Jessica Soltesz, LMSW, Director of Social Health at Kaiser Permanente
  - o Nicolas Powers, MBA, FACHE, Chief Executive Officer at Winding Waters Clinic
  - o Omar Al Rais, MBA, MBChB, Vice President of Operations at Project Access NOW
  - Tyler Stewart, IT Coordinator, White Bird Clinic
- HITOC held two meetings this quarter: April 11 and June 6. In the April meeting, Members
  reflected on the years of work that went into the Strategic Planning process, sharing lessons
  learned and preparing for the work ahead. Members also said farewell to departing members,
  including Carly Hood-Ronick who left HITOC to join OHPB.
- At the June HITOC meeting, new and existing members had the opportunity to reflect on what drew them to HITOC. Members shared their reasons, which included consumer and patient advocacy, eliminating health inequities, reducing technical silos and improving healthcare for rural organizations and residents. The remainder of the meeting focused on health information exchange (HIE) in Oregon, with presentations from Reliance eHealth Collaborative and HIT Commons.

#### **Upcoming Committee Work and Decisions:**

HITOC will focus on its Strategic Plan, exploring what the plan will mean for health IT in Oregon and digging deeper into the six strategies, which focus on patients and consumers, electronic health records, health information exchange, community information exchange, interoperability, and governance. Throughout this work, HITOC members will center health equity and focus on providers that face additional barriers around health IT, such as those in behavioral health and rural areas.

### **Upcoming recruitment needs:**

One seat remains open and reserved for a Tribal representative. Recruitment for this seat is managed through OHA Tribal Affairs and is at the discretion of the Tribes.

#### Support or guidance needs:

HITOC's OHPB liaison, John Santa, ended his second OHPB term in December 2023. John's connection has been an invaluable resource for HITOC, and we welcome a future OHPB liaison.

### **Quarter 2 2024 Committee Update:**

OHA hosted a hybrid Medicaid Advisory Committee (MAC) retreat on May 29, 2024. MAC discussed quality improvement, a technical assistance opportunity from the Center for Health Care Strategies, and OHA's strategic plan. Members engaged in discussion around prioritizing MAC's work for the next year and beyond. Initial priority topics discussed were: 1) Medicaid Waiver implementation (with a particular interest in Health-Related Social Needs), 2) eligibility (continuous enrollment, extended eligibility, and seniors), 3) CCO procurement, and 4) network adequacy. OHA Director Hathi also introduced herself and discussed the MAC's priorities and how they aligned with OHPB and OHA priorities.

The June meeting continued conversation about priorities begin at the May retreat. The MAC hopes to partner closely with OHPB regarding the CCO procurement process. The MAC will work on network adequacy through the evolving consumer subcommittee and responses to the Ombuds reports it receives quarterly. MAC will continue to monitor 1115 Waiver implementation and explore questions about eligibility for services.

The OHA representative on the committee resigned in May. Staff will seek a replacement for this representative. MAC elected Caroline Barrett, MD, as co-chair and voted to begin using a consent agenda at each meeting to share agreed upon norms and reminders.

### **Upcoming Committee Work and Decisions:**

OHA will work with the MAC and the Advancing Consumer Experience subcommittee to transition the subcommittee to a Beneficiary Advisory Council, per new Centers for Medicare or Medicaid Services guidance.

#### Metrics:

The MAC's interest in the 1115 Waiver is largely focused on how OHA will measure success.

#### **Behavioral Health:**

The MAC has a subcommittee that reviews reports from the Ombuds committee. They will return to the full committee in September with a recommendation for actions the MAC can take to support the Ombuds recommendations to improve delivery of behavioral health care for Medicaid recipients in the open-card or coordinated care organization systems.

### **Quarter 2 2024 Committee Update:**

The Metrics & Scoring Committee (M&SC) is tasked with selecting healthcare quality measures for inclusion in the CCO Quality Incentive Program. Through this program, CCOs can earn hundreds of millions of dollars in bonus funds for improving care for OHP members.

#### Since the last Digest:

- Lead staff Sara Kleinschmit began a rotation in Health Policy. Until a new limited duration employee is hired to fill this role, Derek Reinke and Allison Proud will lead M&SC.
- In May, M&SC held its first hybrid meeting since February 2020, with six (6) committee members attending in-person. M&SC plans to continue offering hybrid meeting options two to three times each year.
- M&SC began selecting the draft 2025 incentive measure set and Challenge Pool.
- A recruitment process was initiated to fill the two (2) vacant committee seats. Two new committee members were selected and will begin their terms in July 2024.

# **Upcoming Committee Work and Decisions:**

#### Metrics:

M&SC's statutorily mandated work in 2024 is to make decisions about the measures and benchmarks to include in the incentive program for 2025. This includes consideration of program changes outlined in SB 966 to better leverage the program to advance health equity. In recognition of immediate changes stemming from SB 966, the need to learn from the findings and recommendations of the SB 966 program study, and the statutorily mandated functions of the Committee, the work plan includes:

- Shared space to build equity foundation for the program together. This includes reviewing webinars and papers from equity measurement experts, reviewing efforts in other states, and discussing learnings and program implications together.
- Beginning to explore how the benchmarks used by the program might be leveraged to advance health equity. This includes reviewing current data feasibility and limitations.
- Space for exploring the CMS Core Sets. This is the first year the CMS Core Sets will be used as part of the program. There is a need to orient the Committee to the Core Sets, particularly areas where current incentive measures are not included.

As four current CCO incentive measures are not on the CMS Core Sets (1. Screening, Brief Intervention, & Referral to Treatment; 2. Preventive Dental & Oral Health Visits; 3. Oral Evaluation for Adults with Diabetes; and 4. Cigarette Smoking Prevalence), the workplan includes focused time to discuss these measures. The Committee will consider whether they could be replaced with similar measures that may be included in the CMS Medicaid Core Measure Sets, whether they should be replaced with wholly different measures from the CMS Medicaid Core Measure Sets, or, whether they should be retired without replacement.

The Committee began selection of the 2025 incentive measure set at their May 2024 meeting. This process, and the selection of the 2025 Challenge Pool, will continue through July. The Committee will then shift to selecting benchmarks and improvement targets for each measure from August – October 2024.

### Support or guidance needs:

Senate Bill 966 also directs OHA and OHPB to regularly evaluate the measures selected by the Committee. Inclusion of OHPB is new. In addition, the OHPB has selected metrics as a priority area. The Committee looks forward to working with OHPB on what this review and collaboration might look like moving forward.

#### **Quarter 2 2024 Committee Update:**

The PCPRC met on April 23 and 1) approved the metrics for the primary care value-based payment (VBP) model, 2) received an update on social risk adjustment, 3) learned about potential uses of All-Payer All-Claims (APAC) data and 4) strategies to promote implementation of the model. Members agreed that provider organizations and payers could advocate using the model when negotiating new contracts. To support this two summary model documents are needed, one from the payer perspective and one from the provider organization perspective. Members also discussed the impact of SB 1529 (2022) requiring payers to assign enrollees to an individual or group of individuals who are "primary care providers".

### **Upcoming Committee Work and Decisions:**

When the PCPRC meets on July 24 it will prepare for a presentation to the House Committee on Behavioral Health and Health Care during September 2024 legislative days.
