

Key Accomplishments



Accomplishments:

- Received CMS approval of the Health-Related Social Needs (HRSN) Services Protocol on 02/01.
- HRSN Infrastructure (Community Capacity Building Funds) Protocol and DSHP Claiming Protocol were approved by CMS on 01/05 and 01/19 respectively.
- Received CMS approval of the New Initiatives Implementation Plan on 02/22.
- Climate rules were filed with the Secretary of State (SOS) on 01/23.*
- The CCO Contracting team finished the CCO amendment for both the Medicaid and non-Medicaid contracts for the climate benefit and shared them with CCOs on 01/24.*

^{*}Contracts and rule will be updated with technical changes to align with the CMS-approved HRSN Services Protocol.

Who can receive HRSN climate devices?

To qualify for HRSN benefits, individuals must be a current OHP member AND:


Be in one or more of the eligible groups:

- An adult or youth discharged within the past year from mental health or substance use disorder Institution for Mental Diseases.
- An adult or youth released within the past year from incarceration.
- Have been involved in the Oregon child welfare system at some point in their life.
- Within the next three months or past nine months, transitioning from Medicaid-only to dual coverage (receiving both Medicaid and Medicare).
- Individuals who are homeless, or at risk of becoming homeless.
- A young adult, aged 19-26, with Special Healthcare Needs (starting in 2025).


In addition to being an OHP member and being part of an eligible group, they also need to meet additional eligibility criteria depending on which HRSN service they are applying for.

Eligibility Framework for Climate Devices

Is a Current OHP Member and Part of an Eligible Group



discharged from an IMD.



Involved in the child welfare system.

Transitioning from Medicaid-only to dual coverage.

At risk of becoming houseless.

Has a Clinical Need for a Specific Climate

A health condition that is worsened by heat may qualify for an air conditioner.


Device



A health condition that is worsened by cold may qualify for a **portable heater**.



A health condition that is worsened by compromised air quality may qualify for an air filtration device.





Social Need for a **Device**

OHP members in an Eligible Group with a device-specific clinical need **must also**:



- Not already have a climate device sufficient to meet their needs, and
- Be able to use the device safely in their primary residence



- Ensuring Members Do Not Already Have a Device Sufficient to Meet Their Needs.

 Reasonable efforts are made to determine whether in the last 36 months, the member already has / received a climate device sufficient to meet their medical needs. Members cannot receive a replacement device more than once during a 36-month period.
- Replacing Filters for Air Filtration Devices (AFDs). Members are eligible for up to three replacement filters for every 12-month period following delivery of the device.
- **Device Failure.** Most devices should include warranty within one year of device delivery. If outside warranty period, or damage is not covered by warranty, CCOs should replace or repair the device so long as the individual is still eligible for the device.
- **Utility Costs.** Under HRSN, utility costs cannot be paid for. CCOs may be able to help with increased utility costs under "flexible services" or HRS. Other programs may be available for utility assistance.

Health-Related Services (HRS) vs. Health-Related Social Needs (HRSN) Benefit

- Climate devices and related services that are not covered as HRSN Services could be provided to CCO members through CCO Health-Related Services (HRS) Flexible Services (also called Flex Funds by some CCOs).
- HRS is not an option for Open Card OHP members (FFS).
- In addition to using HRS for climate devices, CCOs may also use HRS to address the member's increased utility costs associated with using a climate device. Utility costs are not covered under HRSN services.
- CCOs that bulk purchase climate devices to support emergency response for CCO members may:
 - Report devices provided to non-HRSN CCO eligible members as HRS.
 - Report undistributed devices as HRS only for devices that will be distributed to non-HRSN eligible members in the future.

Community Capacity Building Funds

What are Community Capacity Building Funds (CCBF)?

- Oregon has been authorized to spend up to \$119 million on Community Capacity
 Building Funds to support the development and implementation of the Health-Related
 Social Needs program.
- Coordinated Care Organizations (CCOs) will administer these funds to eligible community partners.*
- CCOs will be required to use a standardized application and budget request template.
- Eligible Community Partners such as Community Based Organizations (CBOs) and others will be able to apply for and use these funds to support the HRSN program.

*Tribal Governments/Providers will receive a set aside amount of this funding to be administered through a different process

Eligible Groups for Community Capacity Building Funds

Groups that may apply for and receive these funds include but are not limited to:

- Community-based organizations (CBOs)
- Social-service agencies
- Housing agencies and providers
- Food and nutrition service providers

- Case management providers
- Traditional health workers
- Child welfare providers
- City, county, and local government agencies

Please Note: The final list of eligible groups will be finalized with CMS.

Allowable Uses of Community Capacity Building Funds

The Centers for Medicare & Medicaid Services (CMS) has specific allowable uses of CCBF.



Technology

(e.g., new billing systems)



Development of business or operational practices

(e.g., designing new workflows)



Workforce development

(e.g., support for recruiting)




Outreach, education, and convening

(e.g., launching a new learning collaborative)
