



## PEBB's COVID-19 VACCINE BOOSTER INCENTIVE FREQUENTLY ASKED QUESTIONS

1. Do I qualify for the PEBB COVID-19 vaccine booster incentive?

You qualify for the incentive if:

- a. You are a <u>PEBB-eligible</u> full-time, part-time, or temporary State or University employee.
- b. Your local government employer offers PEBB benefits.

If you do not meet any of the criteria above, you do not qualify for the COVID-19 Vaccine Booster Incentive.

2. Do I have to be enrolled in PEBB benefits to qualify?

No. You are still eligible for the incentive if you opted out of PEBB health insurance or declined all PEBB benefits. You must meet the qualifying criteria listed in Q1.

- **3.** Do my spouse/partner and other dependents qualify for the booster incentive? No. Only employees and others listed in Q1 are eligible.
- 4. How do I get the incentive?
  - a. Login to your PEBB account: www.PEBBenroll.com
  - b. On the left-hand side under Resource Tools click on COVID-19 Booster Incentive Form.


- c. Select your booster status (choose only one):

  - ii. Vaccinated and Boosted prior to March 14, 2022, or
  - iii. Vaccinated and have been or will be Boosted on or after March 14, 2022.

- 5. When can I expect to see my COVID-19 Booster Incentive funds?
  - a. State and university employees will receive the incentive in their paycheck at the end of May or beginning of June. It depends on your payroll cutoff date.
  - b. Local government employees should contact their employer's HR department for details.

Please note: The incentive is applied to your gross pay.

6. Is there a deadline to request the COVID-19 Booster Incentive?

Yes, you must submit your attestation by April 30, 2022.

- 7. I filled out the COVID-19 Booster Incentive form but did not receive my incentive. Please contact us at inquiries.pebb@dhsoha.state.or.us.
- 8. Do I need to be fully vaccinated and have received a booster to get the incentive? No. You must have received <u>both shots</u> in a two-shot series or have received the Johnson & Johnson single shot **plus** have had or be scheduled to have the subsequent booster.
- **9.** Do I qualify if I am unable to get the booster due to medical or religious reasons? Yes, you still qualify for the incentive if:
  - a. You meet the criteria listed in Q1 and
  - b. filled out the COVID-19 Booster Incentive form.
- 10. I am unable to access the website.
