Dear Chair Johnson and Vice-Chair Isaacson,

Thank you for your dedication and leadership to this work during a time of change. The Oregon Health Policy Board serves as a stable venue for public engagement, policy development, and agency oversight. This stability will be particularly important as the Oregon Health Authority onboards new leadership and focuses on implementation of several new, transformative programs, including the Basic Health Program and the new 1115 Medicaid Waiver benefits.

Oregon continues to be a leader in health care transformation, and yet, we still face many consistent challenges with health care access, health disparities, and overall affordability. This is why my recommended budget at the start of the year aimed to maintain the coverage gains achieved during the last two years, expand health care coverage statewide, and increase access to services. We must recognize the need to stabilize the health system while we continue to pursue reforms that will serve Oregonians better and help Oregon families thrive.

I also want to acknowledge the Board is comprised of volunteers, many of whom work full-time in addition to providing significant time to the Board and the Board's various committees. Please continue to be mindful of how and where the Board can be of most influence by being specific in your strategies to move the Board's work forward.

As my staff have engaged with the Board's leadership over the past two months, the priority areas that I have identified for the Board will come as little surprise.

I direct the Board to prioritize the following areas:

- Continue to **advance health equity** toward the State's 2030 Goal to eliminate health inequities. The Board must support the agency in defining its strategies and progress toward this goal and lead with equity throughout the Board's broader work.
- Continue championing strategies to reduce health care costs and increase affordability
  for Oregonians. This work should include identifying risks and threats to existing efforts
  and programs, and the Board should work across state advisory committees in doing so.

- Lead public engagement for the next Coordinated Care Organization (CCO)
  procurement with an eye toward member experience and access to care. My office will
  work closely with the agency and Board to establish expectations for the next CCO
  procurement.
- Continue the Board's **metrics alignment** work with a particular focus on upstream strategies to support the work of advancing the state's health equity goals.

Behavioral health is a significant focus of my administration. I encourage the Board to identify where, within the Board's workstreams, you can influence a more responsive and culturally reflective behavioral health system. This may include assessing how members access care through CCOs, without duplicating existing agency or initiative work.

My staff will continue to engage actively with the Board as we work together to make progress on these challenges. I look forward to our partnership on these critical issues.

#### **Welcome and shared agreements**

 PHAB members, subcommittee and workgroup members and staff introduced themselves.

#### Board updates and agenda review

Presented by Kirsten Aird

- A quorum, defined as half plus one of the members, was established at the beginning of the meeting.
- It was noted that this would be Erica Sandoval's last meeting with PHAB.

- The Governor's Office is expected to appoint members to open positions on the PHAB, including Public Health Division Employees Representative and CCO Representative roles.
- Heather Kaisner was appointed as the Health Administrator to represent large counties; she is expected to attend the next meeting.
- PHAB's new positions include CBO Representatives from both rural and urban settings, a Health Equity expert, and a representative for early learning through high school education.
- It was also noted that an Oregon Health Policy member is expected to join PHAB in 2024.
- There has been significant interest in joining the Health Equity Framework
   Workgroup and Public Health System Workforce Workgroup from LPHAs
   members and some Tribal groups.
- Marie Boman-Davis agreed to participate in both workgroups while
   Meghan Chancey and Veronica Irvin volunteered for the Workforce
   committee; Bob Dannenhoffer and Jackie Leung volunteered for the Health
   Equity Framework committee.

- Dr. Sejal Hathi will assume her role as Director of Oregon Health Authority on January 16th; arrangements are being made for her introduction to PHAB.
- Coordination is also underway for Governor Kotek's opportunity to meet with PHAB.

#### **October Meeting Minutes Vote**

 Meghan Chancey motioned to approve the minutes from October's meeting; Erica Sandoval seconded this motion. The vote passed with approval; Michael Baker abstained.

#### PHAB Health Equity Policy & Procedure Update & Vote

Presented by Bob Dannenhoffer

- Data on impacts of racism in Public Health Systems were included in this policy update.
- Statements acknowledging how geography have impacts public health were added.
- Veronica Irvin raised a question about notes included within the document;
   it was clarified that these were working notes not intended for inclusion in final documentation.

- Bob Dannenhoffer made a motion to approve the updates to the policy and procedures. Sarah Present seconded the motion; motion was passed unanimously as follows:

# Public Health Accountability Metrics (CD and Environmental Health Process Measures) Presentation and Vote

Presented by Sara Beaudrault, Tim Menza, Rex Larsen, Julie Sifuentes

- Process Measure Implementation
  - Each LPHA is expected to show progress on two process measures in each of the three priority areas for syphilis, immunizations and extreme heat and air quality.

- Three workgroups of LPHA and OHA subject matter experts were formed to provide recommendations for the process measures, based on best practices and evidence.
- OHA conducted meetings on 11/6 and 11/13 to review the recommendations and solicit feedback from LPHA administrators.
- A survey was fielded from 11/14 to 11/27 to gather additional insights and opinions from the LPHA and OHA staff on the process measures.
- Marie Boman-Davis asked about the reporting mechanism for the process measures, wondering if the program elements would be updated and if OHA would be responsible for housing this data.
- Sara confirmed that related program elements would be updated to reflect the metrics, and that data collection methods and mechanisms are being developed to capture this data.
- Dr. Tim Menza, Rex Larsen and Julie Sifuentes reviewed data and proposed
   LPHA and OHA process measures for each of the three mtrics areas.
- Bob Dannenhoffer asked whether OHA is taking any actions to connect long term health facilities vaccination requirements to possible incentives. There are 29 states that require long term health facilities to vaccinate their residents and Oregon does not anything outlining this idea.
- Rex Larsen responded that OHA is interested in exploring this topic but it is not currently being addressed through accountability metrics.

- Bob responded- This can work; this has been done in other states. Bob noted that statewide approaches are needed.
- Jackie Leung asked a question about community engagement and whether this would be active or passive engagement.
- Sara Beaudrault noted that metrics are an opportunity to be actively engaging
  with communities. She said that, for the purposes of identifying metrics, OHA,
  LPHAs and the PHAB subcommittee relied on connections to other bodies of
  work where communities were directly engaged.
- Jackie Leung also asked if Seasonal Affective Disorder (SAD) would be considered as it relates to mental health effects of climate change due to weather conditions and if concerns about fluoride in water would be an issue for those who are opposed to it in drinking water.
- Sarah Present suggested keeping the flexibility that the last process measure encompasses specific about drinking water and safe drinking water.
- Ryan Petteway expressed concern that the PHAB Accountability Metrics subcommittee has not directly engaged communities in the selection of priority areas, indicators, or process measures.

- Bob Dannenhoffer moved to vote on the process measures and Mike Baker seconded the motion; the measures passed unanimously as follows.
  - Marie Boman Davis yes
  - Bob Dannenhoffer yes
  - Veronica Irvin yes
  - Meghan Chancey yes
  - Sarah Present yes
  - Kelle Little yes
  - Jackie Leung yes
  - Ryan Petteway yes, with concern about lack of community engagement.

#### **Workplan Priorities for 2024**

Presented by Sara Beaudrault

- The meeting continued with a presentation by Sara Beaudrault on the workplan priorities for 2024. The priorities from 2023 were revisited to determine if they are still relevant for 2024 or if changes are needed. The priorities include:
  - 1. Public health system commitment to health equity
  - 2. Public health system improvements and funding
  - o 3. Statewide population health priorities and policies
  - o 4. PHAB structure, business, and member support

- Marie Boman-Davis questioned whether Priority 1 would be more intentional, reflecting the revised statements in the updated policy and procedures. She also suggested that new PHAB members should be included in the discussion of defining these priorities.
- Jackie Leung asked if Priority #3 considers disparity differences in each population group or if it is intended as a blanket statement.
- The meeting then moved on to the required and anticipated work in 2024.
   This includes:
  - Updating the public health modernization funding formula for local public health authorities.
  - Approving the 2024 Public Health Modernization Funding Report.
  - Making recommendations related to future public health modernization investments.
  - Approving the Public Health Equity Framework.
  - Approving the Public Health System Workforce recommendations.
  - Approving the Public Health Accountability Metrics Report, and use of accountability metrics.
  - o Informing the 2023-25 public health modernization evaluation.
  - Updating the charter and bylaws.
  - o Electing a Chair for a two-year term.

Jackie Leung asked about the engagement of Community-Based
 Organizations (CBOs) and whether it is lumped into the equity framework
 and recommendation for investments or weaved throughout. This question
 remains open for further discussion.


