






- Governed by three elected commissioners




Challenges to Policy Work in Jackson County

- 11 local governing bodies
- Bureaucratic red tape
- Low awareness among city leadership
- Political resistance
- Limited capacity
- Unsure of readiness for tobacco policies



Overcoming Challenges and Barriers in Jackson County

- Assessing community readiness is vital to TPEP work
- Use the Policy Change Process Model to guide work
- New biennium, new strategies
- Previous readiness assessment was not sufficient





Community Readiness Assessment Methodology

- Interviewed 24 stakeholders
 - City administrators
 - City councils
 - Chamber of commerce
 - Committee members
- Covered 3 Policy Areas:
 - Tobacco-Free Properties
 - Tobacco Retail Licensing
 - Point of Sale Policies
- Discussed community climate, leadership knowledge, businesses' attitudes, and community concerns



Assessment Scoring and Analysis

 Scored and assessed by Jackson County ADPEP, TPEP and Epidemiologist

<u>Interviews scored on six</u> <u>dimensions:</u>

- Overall community climate
- Overall leadership climate
- Community support
- Leadership support
- Leadership knowledge
- Implementation status

Policy Areas:

- 1. Tobacco-free properties
- 2. Tobacco retail licensing
- 3. Point of Sale



The Importance of Equity

- Health equity partners provided insight through equitable lens
- We want to make sure new policies will not disproportionately impact anyone
- Ensures equal playing field for all



It's Worth the Work!

The Assessment Identified:

- Community priorities and values
- Areas of resistance and support
- Potential champions for tobacco prevention
- Favorable policy options
- How we can help local jurisdictions

Key Takeaways:

- Policy Change Model is a helpful tool for TPEP
- Assessment is vital to policy work
- Interviews served as first step to stakeholder relationships
- Created awareness of local prevention efforts and policy options



June 2016 - Dec 2018



Event	Outcome
New Public Health Director	New support for TRL
Sept 2016 Policy Session: Asked to adopt a framework to license marijuana and tobacco retailers.	The BCC voiced support for the concept, but chose to wait for the outcome of the 2017 Oregon legislative session. The BCC asked H3S to return if the state did not pass TRL.
Legislative session	TRL did not pass
Jan 2018 Policy Session: Explained TRL, the need and benefit. Proposed a process to move forward	BCC <i>approved</i> Public Health to proceed with <i>community engagement</i> to assess support for TRL.
Power Mapping Exercise	Established 'ground rules' and strategy to move forward
Completed Economic Impact Analysis	Demonstrated TRL has little negative impact on business
Presented to City Managers	Recommended presenting to councils
Presentations to City Councils	4 Resolutions 1 letter of support 2 do not support 1 no position 2 no response
Presentations to Chambers of Commerce	No direct opposition
Oct 2018 Policy Session: Updated BCC on community engagement. Shared results of economic impact assessment. Requested permission to move forward developing an ordinance.	BCC supported TRL. Directed Public Health to engage tobacco retailers directly, collect letters of support, and develop an ordinance with county counsel.
Listening sessions with retailers	3 businesses opposed TRL
County Administrator retired	Lost TRL champion



•	Jan 2019 Business Meeting: Requested approval of a resolution supporting a county-wide TRL and approval to develop an ordinance with county council.	BOH signed a resolution in support of TRL and directed Public Health to move forward with TRL ordinance.
	Public Health Director resigned	Lost experienced TRL champion
	New County Administrator	Little knowledge of TRL
	BCC raised Vehicle Registration Fee	Negative community response
•	Feb 2019 Policy Session: Presented a draft ordinance for a county-wide TRL. Requested approval to proceed with ordinance	BOH directed Public Health to conduct more in-depth engagement with tobacco retailers and convene a community task force.
	Tobacco Retailers Interviews	65% support or neutral to TRL
	Department Director requested community engagement report for administrator and commissioners	In graphic design after multiple drafts and lapse in time.
	Facilitated TRL Task Force	100% support for TRL

Task Force Results



- Unanimously support TRL
- Support license fee that sustains program
- Agree on a penalty structure for illegal sales to minors
- Diverging opinions for minimum distance from schools
- Did not discuss flavors, density, pricing, or pharmacies

Lessons Learned



- Power mapping exercise was key
- Multi-disciplinary leadership team meetings maintain communication and consensus on strategy
- Engage County Counsel early
- Talk one-on-one with elected leaders or their policy advisors to learn concerns.
- Ride the elevator
- Educate decision makers & assess readiness multiple times
- Listen to meetings to learn decision makers' values
- Engage retailers one on one early

Lessons Learned



- Reframe messages for different audiences
- Make the business case for TRL
- Document all Q & A raised during presentations
- Timing can make or break
- Pause to educate new leaders
- Seize opportunities (increased sales to minors)
- Drive timeline
- Dig deep for resilience and silver linings
