





# Individual-focused strategies

Prevention efforts aimed at providing information, building skills or supporting individuals or targeted groups of individuals.



# Environmental policy strategies

Prevention policy strategies aimed at changing or influencing community environments, conditions, standards, institutions, structures, systems that shape behaviors.



#### Policy strategies can

- Reach entire populations
- Create changes in community norms, systems and behaviors
- Instill commitment toward longterm, sustainable solutions
- Compliment reinforce a variety of prevention strategies
- Protect people and promote health!














A Comprehensive Approach to a Persistent Problem

#### Examples: local alcohol policy

- Require community-event alcohol policies
  - Limit places that sell and serve alcohol
    - Conditional Use Permits (CUPs)
- Deemed Approved Use Ordinances (DAUO)
  - Limit advertising on store-front
  - Time, place and manner nuisance laws
    - Social host ordinances
    - Regular compliance checks


