1. 3. PRMG at grow site registered before 1/1/15 & within city limits & zoned residential (grandfathered grow site)	No more than: <ul style="list-style-type: none"> • 24 mature plants • 48 immature plants 24 inches or more in height • 144 immature plants less than 24 inches in height 	<ul style="list-style-type: none"> • In order for a grow site to be considered “grandfathered” it must meet certain criteria and be approved by OHA. • A household at a grow site in this category is permitted to have 4 personal plants in addition to the medical marijuana plants.
4. PRMG at grow site outside city limits or inside city limits but not zoned residential:	No more than: <ul style="list-style-type: none"> • 48 mature plants • 96 immature plants 24 inches or more in height • 288 immature plants less than 24 inches in height 	<ul style="list-style-type: none"> • A household at a grow site in this category is permitted to have 4 personal plants in addition to the medical marijuana plants.

5. PRMG at grow site registered before 1/1/15 & outside city limits or inside city limits but not zoned residential (grandfathered grow site)	No more than: <ul style="list-style-type: none"> • 96 mature plants • 192 immature plants 24 inches or more in height • 576 immature plants less than 24 inches in height 	<ul style="list-style-type: none"> • In order for a grow site to be considered “grandfathered” it must meet certain criteria and be approved by OHA. • A household at a grow site in this category is permitted to have 4 personal plants in addition to the medical marijuana plants.

NOTES:

- "Person responsible for a marijuana grow site," or "PRMG" means any individual designated by a patient to produce marijuana for the patient, including a patient who identifies themselves as a person responsible for the marijuana grow site, who has been registered as a PRMG by the Authority under OAR 333-008-0033.
- A PRMG designated by a patient may not produce more than six mature marijuana plants, twelve immature marijuana plants that are 24 inches or more in height, and thirty-six immature marijuana plants that are less than 24 inches in height for each patient.
- If the registration of a PRMG designated at a grow site that was grandfathered under ORS 475C.806(3)(b) or (4)(b) is suspended or revoked and they re-register, subsequent plant limits at an address within city limits and zoned residential will be: no more than 12 mature plants, no more than 24 immature plants 24 inches or more in height and no more than 72 immature plants less than 24 inches in height.
- If the registration of a PRMG designated at a grow site that was grandfathered under ORS 475C.806(3)(b) or (4)(b) is suspended or revoked and they re-register, subsequent plant limits at an address outside city limits or not zoned residential will be: no more than 48 mature plants, no more than 96 immature plants 24 inches or more in height and no more than 288 immature plants less than 24 inches in height.
