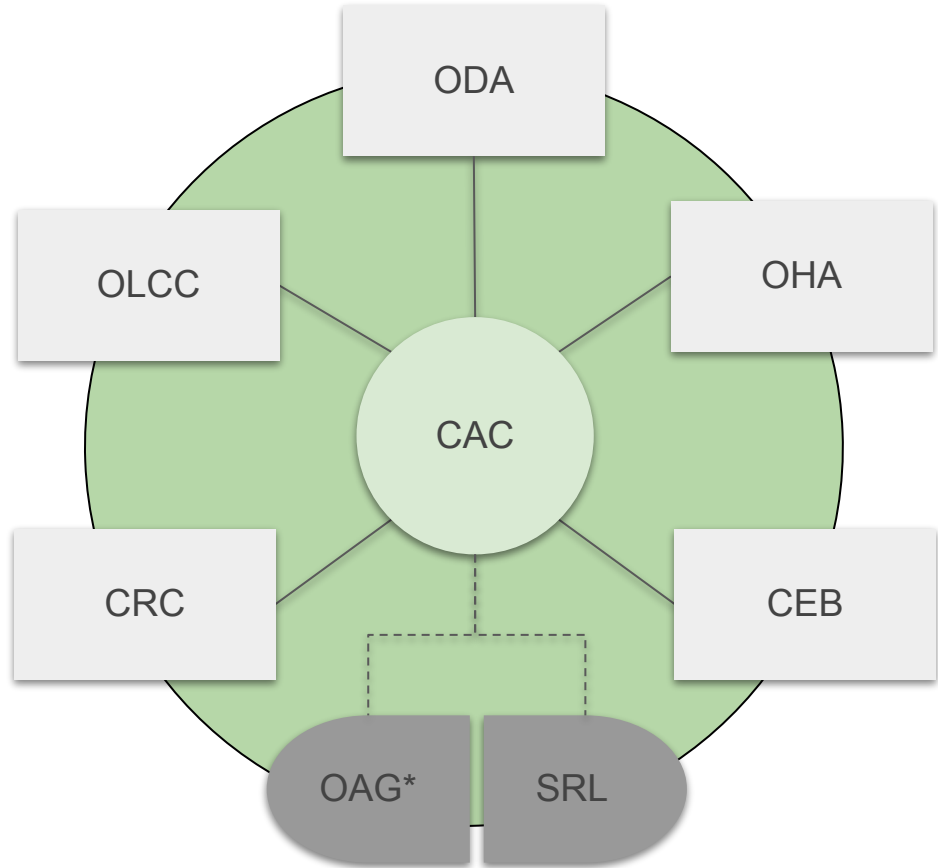

Medical Program Snapshot

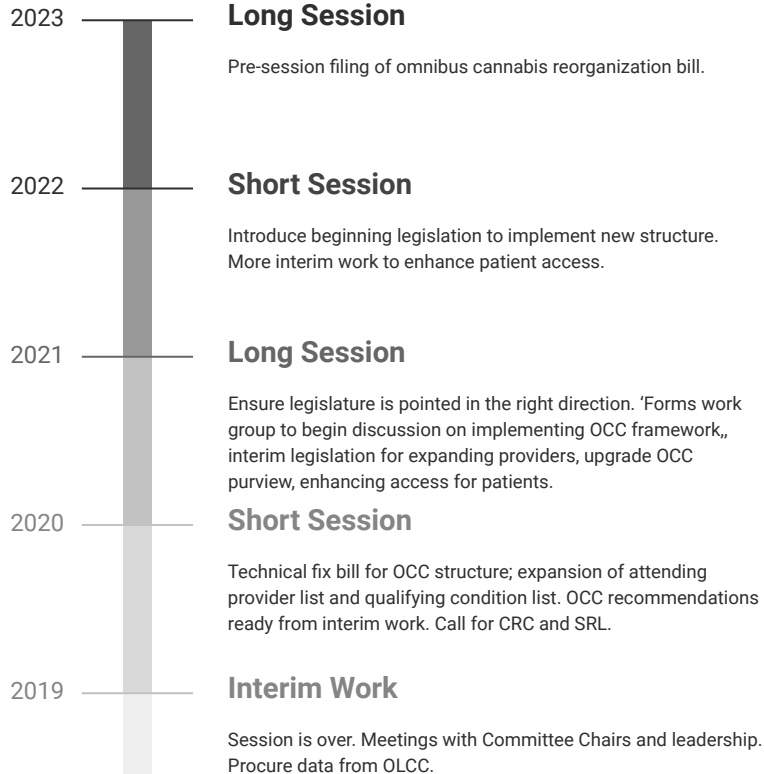
The Oregon Medical Cannabis Program (OMCP) is a public health program within the Oregon Office of Cannabis Regulation (OOCR). The program is co-administered by the Oregon Cannabis Governing Coalition (OCGC) which includes the Oregon Department of Agriculture (ODA), Oregon Liquor Control Commission (OLCC), Oregon Health Authority (OHA), Cannabis Equity Board (CEB), and Cannabis Research Consortium (CRC).

The purpose of the OMCP is to ensure that patients have long-term access to affordable, safe, diverse and efficacious cannabis and cannabinoid products from hemp and marijuana for medical use, to protect the patients' growers producing diverse cultivars, and to ensure public benefit from existing and emerging agronomic, scientific, medical, and public health research on cannabis as it impacts clinical care, the cannabis industry, the environment, and the public health at large.

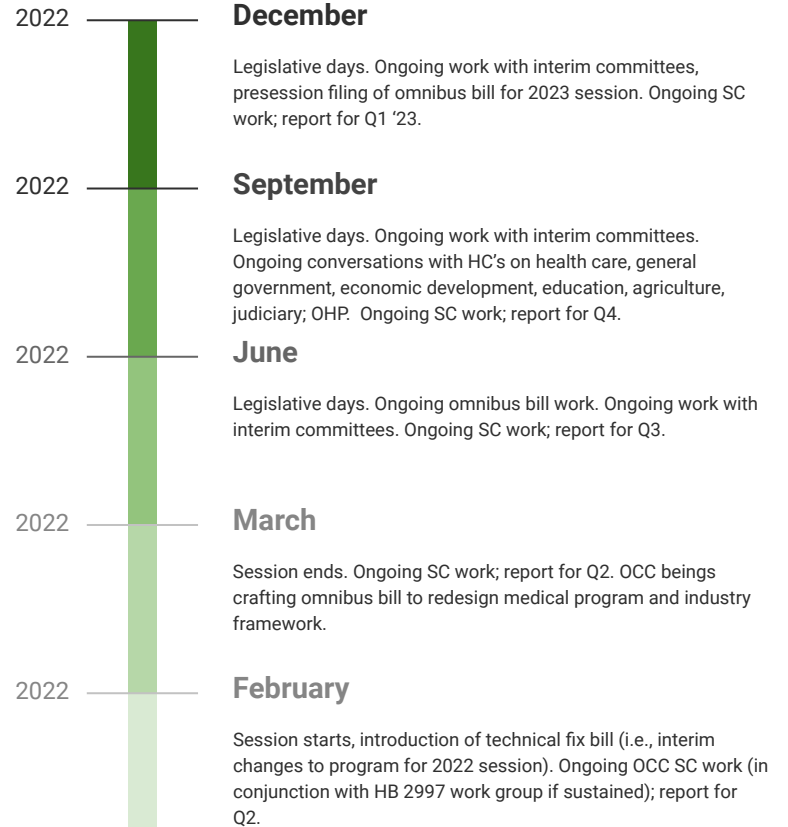
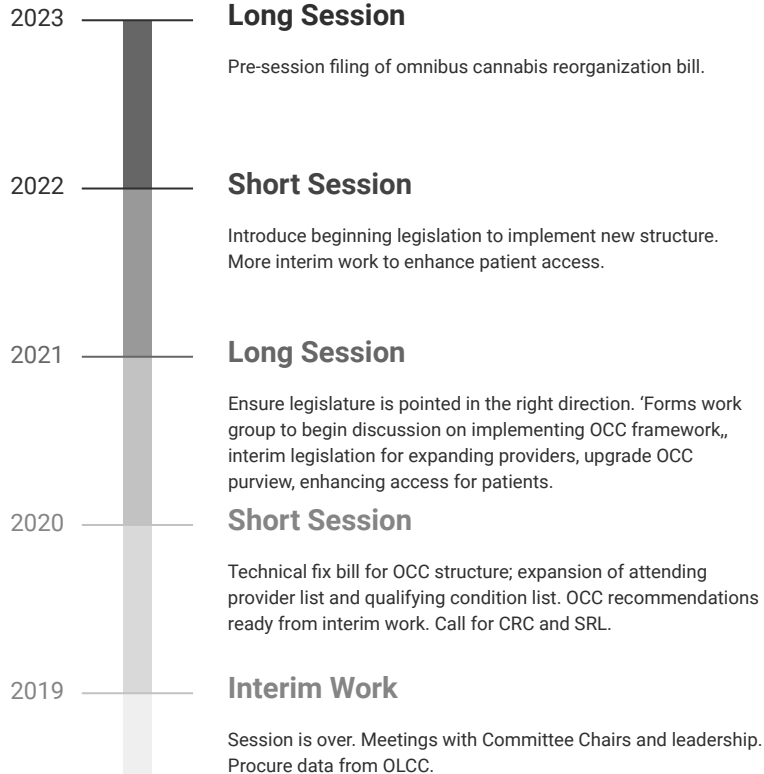
OMCP registrants include qualifying patients, patient caregivers, attending providers*, designated growers, and cooperatives.
