Subject: Notice of Temporary and Proposed Permanent Rulemaking:

OAR chapter 333, division 18 - Disease Reporting

The Oregon Health Authority (OHA), Public Health Division, has temporarily amended OAR 333-018-0005 relating to reporting of diseases in out-of-state residents; and amended OAR 333-018-0016 relating to reporting of COVID-19 specifically. The amended rules require reporters to report out-of-state cases to the jurisdictional public health authority of the patient's residence, rather than to OHA. The amendments remove language rendered obsolete by electronic laboratory reporting. They also require reporting of positive and negative COVID-19 laboratory reports by those testing outside of traditional laboratories—i.e., those conducting "waived" laboratory tests in accordance with the federal Clinical Laboratory Improvement Amendments of 1988 (CLIA).

These temporary rules are effective January 7, 2021 through March 29, 2021. The full text of the temporary rules can be viewed at:
