Subject: Notice of Proposed Permanent Rulemaking for OAR chapter 333, division 18 – Amending and repealing rules relating to reportable diseases

The Oregon Health Authority (OHA), Public Health Division (PHD), Acute and Communicable Disease Prevention (ACDP) Section is proposing to permanently amend Oregon Administrative Rules (OARs) in chapter 333, division 18 relating to disease reporting requirements. Proposed amendments align Oregon's list of select biological agents and toxins with the U.S. Department of Health and Human Services (HHS) and U.S. Department of Agriculture (USDA) select agent lists; clarify reporting requirements for toxigenic diphtheria, brucellosis, arthropod vector-borne infections and conditions, and non-respiratory nontuberculous mycobacteria (NTM); and streamline COVID-19 requirements by maintaining reportability of COVID-19 pediatric deaths and multisystem inflammatory syndrome (MIS-C), while removing requirements for test results, cases, and adult deaths, which are no longer needed since COVID-19 is no longer a generally reportable disease in Oregon.
