

# County Watch List Data

Counties are placed on the watch list when there is a sporadic case rate of  $\geq 50$  per 100,000 in the last two weeks and the county has  $>5$  sporadic cases in the last two weeks.

Sporadic cases are those cases that cannot be traced to a source, which indicates community spread.

Counties remain on the watch list for a minimum of three weeks and until their sporadic case count drops below 50 per 100,000 or  $\leq 5$  cases in the previous two weeks.

The watch list helps policymakers and the COVID-19 response team to prioritize resources and assistance to the counties that are seeing the broadest spread of COVID-19. The assistance offered to a particular county depends on the assessment of its needs. Often it includes epidemiological assistance and staffing support. Presence on the watch list does not indicate that a county is being moved back a phase in reopening, nor is it punitive.
