

## Oregon Reporting Requirements

The health and safety of all Oregonians is important and correctional health staff play a significant role as frontline care providers in disease prevention and control in Oregon. Incarcerated populations are disproportionately affected by certain infectious diseases, such as [STI's](#), [hepatitis B and C](#), [TB](#), and [HIV](#). Institutional settings also present higher risk of respiratory and skin infections. Appropriate medical care, diagnosis, treatment and timely reporting of notifiable conditions can improve and protect the health and safety of incarcerated patients, correctional staff and the community.

When a reportable public health disease or incident is recognized, it is important to document the occurrence so a response, such as a consultation or investigation, is undertaken. Sometimes facilities are apprehensive about public health investigations, but prompt reporting to and investigation by public health staff allows for rapid implementation of control measures and prevention of additional cases. Investigation goals include identification of risk factors for spread of infection, and identifying, recommending and implementing corrective actions to protecting incarcerated persons, fellow staff members and community members.


### Communicable Disease Reporting

The [Oregon Public Health Division's Acute and Communicable Disease Program \(ACDP\)](#) maintains on-line and printed information that includes the state's [Reportable Diseases](#), current [Communicable Disease Reporting Rules](#), and information for [health care providers](#) and [local health departments](#), including [investigative guidelines](#), [notifiable disease case report forms](#) and downloadable [Disease Reporting posters](#). Lastly, the [Oregon Public Health Division](#) publishes weekly, monthly, annually [reports](#) to inform health care providers and the public about infections identified in Oregon.

### Who is required to report communicable disease?

In Oregon, all health care providers and laboratorians are required by law to report [certain diseases or conditions](#) to the [local health departments](#). The [timing of the](#)

[health care provider reports](#) is specified to reflect the severity of the illness or condition and the potential value of rapid intervention by public health agencies.

### How and where to report communicable disease?

When the [communicable disease contact](#) within the [local public health department](#) cannot be reached within the specified time limits, reports must be made directly to [OHA-ACDP](#), which maintains an around-the-clock public health consultative service.

### What about confidentiality?

Incarceration presents unique confidentiality issues for health care providers. Protecting the health of persons incarcerated in your facility, correctional employees, visitors and recent outside contacts may require the reporting of specific protected health information of individuals. The [Health Information Privacy Rule](#) permits covered entities to disclose protected health information without authorization for specific health purposes. The [CDC](#) and the [Office of Civil Rights](#) have also issued guidance on HIPAA. It is important to understand [Oregon Administrative Rules \(OARs\) related to Investigation and Control of Disease](#), your entity status and facility protocols.

### Is there training available for health care providers?

The CDC offers [epidemiologic case studies](#) for on-line learning. The Acute and Communicable Disease Program offers Communicable Disease Training series that




includes Communica-

ble Disease Control: *The Basics* (CD 101) and *Outbreak Investigation Essentials* (CD 303).

The [Fall 2015 CD training series is scheduled for Oct 22 and 23rd in Bend, OR.](#)

- The *CD 101* course covers the basics of communicable diseases, reporting requirements for notifiable diseases in Oregon, the use of the Oregon Investigative Guidelines for disease prevention and control, interviewing techniques for cases and controls, and proper specimen handling for transport to OSPHL.
- The *CD 303* course focuses on disease surveillance, descriptive epidemiology, interviewing and questionnaire development, study design and analytic methods, elements of decision making, and basic steps in outbreak investigation.
