## End HIV Oregon launches

On Dec. 1st, World AIDS Day, the Oregon Health Authority (OHA) launched the *End HIV Oregon* initiative during a media event at the Portland State Office Building that was attended by government officials and community partners. *End HIV Oregon* envisions a state in which new HIV infections are eliminated and where all people living with HIV have access to high-quality care, free from stigma and discrimination.


The *End HIV Oregon* strategy is the culmination of a two-year planning process. Community members from across Oregon came together to identify the most pressing issues to address in order to eliminate new HIV infections.

The *End HIV Oregon* strategy centers around three themes:

- **Testing is easy:** Confidential testing available throughout Oregon makes testing simple, convenient and fast.
- **Prevention works:** Core prevention programs must be maintained and expanded, and use of new tools, such as pre-exposure prophylaxis (PrEP), a daily pill that prevents infection, must be accelerated.
- **Treatment saves lives:** Effective treatment, called viral suppression, among HIV-positive people helps infected people live long, healthy lives and has the potential to prevent the largest proportion of new HIV infections.

Due to federal funding mechanisms, planning for delivery of HIV care services has historically occurred separately for the Portland metro area and the balance of state. The *End HIV Oregon* strategy is the first plan that is statewide, inclusive of all 36 counties and addresses the entire HIV continuum, from prevention through care.

OHA is leading the multi-year *End HIV Oregon* effort, with partners that include local health departments and community-based organizations and will include investments in new initiatives statewide. One of the major calls to action from *Facing Addiction in America: The Surgeon General's Report on Alcohol, Drugs and Health* is for increased integration of primary care and addiction services. In this webinar, January 5, 3:30 pm ET, join one of the authors of the report, Dr. Connie Weisner, in a discussion of the findings and what efforts are needed to support integrating screening, assessments, interventions, use of medications, and care coordination. HRSA-funded primary care providers will offer examples about the steps they take to successfully and continually address substance use.
