In the digital age, frauds and scams are an unfortunate part of doing business online. During the holiday season, Social Security has traditionally seen a spike in phishing scams, and we want to protect you as best we can.

We urge you to always be cautious and to avoid providing sensitive information such as your Social Security Number (SSN) or bank account information to unknown individuals over the phone or internet. If you receive a call and aren't expecting one, you must be extra careful. You can always get the caller's information, hang up, and — if you do need more clarification — contact the official phone number of the business or agency that the caller claims to represent. Never reveal personal data to a stranger who called you.

Please take note; there's a scam going around right now. You might receive a call from someone claiming to be from Social Security or another agency. Calls can even display the 1-800-772-1213, Social Security's national customer service number, as the incoming number on your caller ID. In some cases, the caller states that Social Security does not have all of your personal information, such as your Social Security number (SSN), on file. Other callers claim Social Security needs additional information so the agency can increase your benefit payment, or that Social Security will terminate your benefits if they do not confirm your information. This appears to be a widespread issue, as reports have come from people across the country. These calls are not from Social Security.

Callers sometimes state that your Social Security number is at risk of being deactivated or deleted. The caller then asks you to provide a phone number to resolve the issue. People should be aware the scheme's details may vary; however, you should avoid engaging with the caller or calling the number provided, as the caller might attempt to acquire personal information.

Social Security employees occasionally contact people by telephone for customer-service purposes. In only a few special situations, such as when you have business pending with us, a Social Security employee may request the person confirm personal information over the phone.

Social Security employees will never threaten you or promise a Social Security benefit approval or increase in exchange for information. In those cases, the call is fraudulent, and you should just hang up. If you receive these calls, please report the information to the Office of the Inspector General at 1-800-269-0271 or online at oig.ssa.gov/report.

Remember, only call official phone numbers and use secured websites of the agencies and businesses you know are correct. Protecting your information is an important part of Social Security's mission to secure today and tomorrow.

Opportunity to provide public comment on PrEP access by 12/26

The United States Preventive Task Force released a draft statement which states that “clinicians will offer pre-exposure prophylaxis (PrEP) with effective antiretroviral therapy to persons who are at high risk of HIV acquisition”

This would have an important impact on the [END HIV Oregon](#) goal of 100% of Oregonians who are most in need of PrEP having access to it.

Important update from Oregon Health Authority that will improve access to Hepatitis C treatment

Yesterday the Oregon Drug Use Review/Pharmacy & Therapeutics (P&T) Committee, which advises the Oregon Health Authority on prescription drug coverage, recommended a change in prior authorization criteria which will expand treatment access to all Oregon Health Plan (OHP) patients with chronic hepatitis C, without fibrosis restrictions.

"I look forward to approving this recommendation to expand treatment coverage for OHP members," said OHA Director Patrick Allen. "Oregon has the highest mortality rate associated with hepatitis C in the country. We have an opportunity to eliminate hepatitis C in our state, and this is a key strategy to get us there."

Chronic hepatitis C infection is the leading cause of complications from chronic liver disease, including cirrhosis, liver failure, and liver cancer. People with hepatitis C often show no symptoms. Patients can unknowingly have the disease for decades before it becomes problematic, and sometimes it remains asymptomatic and only a screening test identifies the presence of the virus.

Hepatitis C is most common in the baby-boom generation, which has the highest burden of the consequences of chronic infection, such as liver cancer and death.

Over the past year OHA has been taking steps to expand treatment coverage, and the P&T Committee has been continually monitoring the coverage criteria and emerging evidence on hepatitis C treatment.

The P&T Committee initially prioritized treatment for patients in greatest need of treatment. Policies in place approve treatment for patients with fibrosis stage 2 (F2) or greater, and all stages for individuals with HIV co-infection.

In September the P&T Committee recommended an update to the prior authorization requirement. It would remove the active treatment requirements for those with substance use disorder (SUD) and incorporate the necessary additional support into case management programs. This means the requirement that patients must be in active SUD treatment will be removed by January 1, 2019.

OHA is requesting a total of \$107 million for the 2019 biennium, \$10 million of which is state General Funds, to support the ongoing cost of treatment expansion. The agency request was funded in Governor Kate Brown's proposed budget, which was released November 28.

The P&T recommendations head to OHA Director Allen for approval. The agency will then enter a 60-day notification period, with an expected implementation date of March 1.

Cascade AIDS Project (CAP) is very pleased to announce a partnership with Gilead Sciences, Inc. for the 2018-2021 Aging Well Program. Gilead is funding the three-year \$375,000 program that focuses on supporting the wellbeing of aging adults living with and affected by HIV.

The Aging Well Program will mobilize long-term survivors, create a coalition of professionals in related fields, host educational/social events for survivors, improve communication and information sharing, and evaluate efforts – all focused on aging adults. The program also aims to directly reach aging adults living with and affected by HIV through a Long-Term Survivor Leadership Caucus and several social/educational events. Further the program aims to engage professionals working in HIV services and allied disciplines annually through a newly formed Oregon Aging Well with HIV Coalition. Finally, the program will have a broad communications campaign consisting of an Aging Well website, social media activities and print publications.
