Prep/Pep Prescribing Training for Oregon Pharmacists

Training requirements: In order to start prescribing PrEP and PEP, the Oregon Board of Pharmacy requires that pharmacists complete "a comprehensive training program related to the prescribing and dispensing of HIV prevention medications, to include related trauma informed care." It is up to pharmacists to determine if a training program meets these criteria prior to participating.
