New Funding to Support Disease Intervention Specialist (DIS) Across Oregon



Last summer, the STD Prevention Program was notified that new five-year funding (American Rescue Plan Act) would be made available through its CDC STD grant to expand HIV/STD partner services and case investigations – with a particular focus on hiring and retaining new Disease Intervention Specialists (DIS) in underserved areas and in rural communities to provide more equal access to care.



To ensure DIS capacity is more fully resourced across the state, the OHA STD Program put forward a proposal to the Conference of Local Health Officials (CLHO) that funding be made available to all counties not currently funded under the HIV/STD Early Intervention Services & Outreach (EISO) contracts. This proposal was officially approved at the December 2021 CLHO meeting.

We're pleased to announce that funds have begun to be distributed to counties eligible for the new DIS funding! Two million dollars will be distributed annually to county health departments with funding secure through December 2025. This new funding covers some or all of the staffing costs for 27 staff acting as DIS across the state. Combined with DIS funded by EISO contracts and HIV Prevention funding, there will be 55 staff acting as DIS across the state by the end of 2022!

The HIV/STD Prevention Program is taking a number of actions to support counties across the state with their new and existing DIS staffing:

- A new STD Prevention Specialist position is being hired to coordinate training and provide technical assistance and support to the DIS workforce in Oregon. We hope to have this position filled later this spring.
- A new section has been added to the <u>STD LHD Resources page</u> with resources for counties hiring and training new DIS. It includes a sample position description, training plan, and links to existing training offerings.
- A contract with the National Coalition of STD Directors (NCSD) to provide training support
 and conduct DIS training needs assessments across the state is close to being finalized.
 NCSD will produce training materials for new and experienced DIS to supplement the new
 official CDC training for DIS coming this summer.
