PHD's Cross-Division Climate Work Group

Our Internal Work Group meets monthly and includes members from the following PHD programs:

Partnerships with Local Health Jurisdictions

- The program maintains a Technical Assistance list-serve that includes approximately 10 LHJs working on climate and health. This list-serve will serve as the beginning of a new statewide Climate and Health Network.
- We developed a new Resilience Planning toolkit based on the lessons learned by local health jurisdiction partners.
- The program was invited to present and received input from the Coalition of Local Health Official (CLHO) leaders and sub-committees.
- We completed a Social Vulnerability Assessment and developed a set of maps that can be used by local health jurisdictions to communicate climate risks.
- The Program co-leads a Drought Work Group within the Public Health Division and conducted a series of informational interviews with local health partners to identify needs and opportunities.


Resilience Advisory Group

- The program partners with Oregon Climate Research Institute to apply climate data to public health resilience planning.




- We provide social vulnerability data and technical expertise to the Dept. of Geology and Mineral Industries and Dept. of Land Conservation and Development.
- We are technical advisors on a climate project of the Confederated Tribes of Umatilla Indian Reservation.
- Over 50 stakeholders were involved in the development of the Oregon Climate and Health Profile Report. Here is what two participants said:

National Leadership

- We co-lead a national community of practice on climate communications and stakeholder engagement.
