



*This summary highlights program activities, accomplishments and partnerships in the 2015-16 grant period.*



### **Achievements in Planning: The Oregon Climate and Health Resilience Plan**

The Climate and Health Program released a new Resilience Plan for Oregon’s public health system. The plan outlines a set of actions that our public health workforce can take to address climate change. These recommendations build on the findings of the 2014 Oregon Climate and Health Profile Report and were developed through the collaboration of over 60 different partners and stakeholders representing local health jurisdictions, community based organizations, state public health programs, partner state agencies and commissions, and academic institutions. The strategies recommended in the plan align with Oregon’s Public Health Modernization priorities and will be evaluated over the next five years of implementation.

### **Achievements in Policy**

The Climate and Health Program:

- Played a primary role in the development of the Public Health Division’s *Healthy Places Initiative*, a new policy framework for addressing emerging environmental risks in Oregon.
- Convened the Public Health Division’s (PHD) Drought workgroup and developed new recommendations for PHD’s role in the integrated drought response annex.
- Joined with Oregon’s Preparedness, Epidemiology and Surveillance Team (PSET) in attending OSU’s Public Health Policy Institute.
- Partnered with Oregon’s Health Security Preparedness and Response (HSPR) program to integrate Climate Resilience strategies into Oregon’s existing Public Health Preparedness Capabilities Assessment tool.
- Joined the state’s Inter-Agency Sustainability Network and now serves as the sustainability liaison for the Oregon Health Authority’s Public Health Division.
- Submitted comments on the State’s draft Cap and Trade study for State legislators.

### **Achievements in Leadership**

The Climate and Health Program:

- Presented the Resilience Plan to PHD’s Strategic Leadership Council as one of the first examples of a planning project completed using Oregon’s new Public Health Modernization framework.
- Received the invitation to join the NW Regional team of authors for the next National Climate Assessment.



## Achievements in Communications

The Climate and Health Program:

- Became the first PHD program to use animated explainer videos. The video scripts were reviewed and adapted based on the input from the Office of Equity and Inclusion, the So-Health-E Youth Council, and a Public Health Division focus group.
- Created five case study videos that highlight climate-related work occurring in health departments across the state and are featured on a new Climate and Health YouTube Playlist.
- Published the Resilience Plan as an interactive digital publication, hosted a press conference for the release and distributed the plan through our first social media campaign.



## Achievements in Research and Assessment

The Climate and Health Program:

- Participated in the launch of a new regional collaboration with Washington and Idaho to explore alignment for future assessment and study.
- Convened partners on the subject of wildfire and health (CDC, NIOSH, and PHD program partners).
- Participated in research conversations with the Portland State University, NW Center for Public Health Practice, Oregon State University, Oregon Health and Sciences University, NW Climate Hub, and the University of Washington.
- Participated in ASTHO's climate and mental health study, CDC's Drought Response study, and CDC's Climate Communications study.
