DMCE Unit

- Receives and enters water quality test results and operational reports for water systems.
- Verifies data meets compliance monitoring requirements.
- Sends monitoring reminders to water systems.
- Notifies water systems of monitoring and reporting violations and for failure to meet federal standards.
- Maintains <u>Drinking Water Data Online</u> website.

DMCE mailbox versus Compliance mailbox

DMCE mailbox (dwp.dmce@odhsoha.oregon.gov)

- Used by laboratories, water suppliers, field staff
- Submit water quality results and operational data
- Auto-reply email is receipt of record

Compliance mailbox (compliance.dw@odhsoha.oregon.gov)

- Used by regulators / field staff
- Not used by laboratories, water suppliers

Please do not copy mailboxes on other communications.



Data to send to compliance mailbox:

- Completed coliform investigations
- Violation return to compliance (RTC) requests
- Monitoring schedule change requests
- New water system / inventory change requests are not accepted
 - Use Survey123 application ArcGIS Survey123
 - Exception for ODA new WS requests
- Completed water system surveys (include cover letters)

Please clearly describe your compliance request in the email.



When submitting coliform investigations to DMCE:

- Ensure all form information is completed
- Identify corrective action items and due dates on investigation form.
- A compliance schedule will be entered into Data Online.
- Email is sent to field staff when corrective due date is approaching.
- A violation will be issued if corrective due date is not met.

- Use current version of form and submit as PDF (preferred) or unprotected Word file to <u>compliance.dw@odhsoha.oregon.gov</u>.
- A survey backlog added to Data Online shows surveys received but not entered https://yourwater.oregon.gov/wss backlog.php
- If you notice inaccurate information online, check to see if the survey has been entered before notifying DMCE.

- Chemical monitoring reminders will be sent to water suppliers by email in early November.
