PFAS Rules

- Proposed rules announced on 3/14/23
- MCL of 4 parts per trillion (ppt) for PFOA and PFOS and a hazard index of 1.0 for four additional PFAS compounds.
- Routine monitoring of all community and non-transient noncommunity water systems
- Public comment by 5/30/23
- Final rule by the end of 2023 or early in 2024
- Up to two years for states to develop regulations and obtain primacy after the rule is final
- 146 community water systems in Oregon monitored in 2021 and 2022
 - Eight systems had PFAS detections



Consumer Confidence Report (CCR) Rule Revisions

- Twice a year for PWSs serving 10,000 or more people
 - Unless new violations, same report can be delivered in the second half of the year
- If electronic CCR, provide a link to consumers
- Better clarity and organization
- More water quality information
- Translation service for consumers with limited English proficiency (LEP)
- Public comment by 5/26/23
- Implementation expected by April 1, 2025



Cyber security in Sanitary Surveys (Guidance)

- Applicable to PWSs uses Industrial Control System (ICS) or other operational technology (OT)
- Same frequency as sanitary surveys (3-5 years)
- Options
 - Option 1: PWSs conduct self-assessment or third-party assessment of cybersecurity practices
 - Option 2: Primacy agency evaluation of cybersecurity practices during the sanitary survey
 - Option 3: Alternative State Program for Water System Cybersecurity
- EPA workshop with tabletop exercise for PWSs in September 2023
