| 410-130-0246 | Establishes a distinct rule for blood lead level testing. Lead screening has historically been incorporated into broader rule for Early and Periodic Screening, Diagnostic and Treatment program rules. Establishing this distinct rule will bring OHA into compliance with Center for Medicare and Medicaid Services (CMS) and Children's Health Insurance Program (CHIP). |
