Reminder about Coverage for Tubal Ligations

Recently, we've received a number of questions about whether the RH Program, through RHAF, covers tubal ligations. RHAF does not cover tubal ligations. If a RHAF enrollee is interested in getting a tubal, we encourage you to support them in enrolling in OHP, if eligible. OHP covers tubals for members regardless of citizenship or immigration status. We know that not all RHAF enrollees are eligible for OHP (e.g., income is too high for OHP) and that this represents a gap in access. For these clients, it might be worth researching whether any hospitals in your community offer charity care or some other form of financial assistance for people seeking tubals.
