Updated Fact Sheet on Minor Consent for STI Testing and Treatment

TakeMeHome Eligibility Has Expanded!

Free mail-order HIV/STI/HCV testing is now available for Oregonians 14 years of age and older

The Oregon Health Authority contracts with NASTAD to operate Oregon's home delivery HIV/STI testing program called TakeMeHome. The program is designed to focus on persons at-risk for HIV/STIs who have barriers to testing in clinical settings and/or have not been tested for HIV/STIs within the previous 12 months. The program offers no-cost mail-order rapid HIV self-tests, rapid syphilis self-tests, and self-collected STI and HCV tests. STI and HCV tests are processed by Molecular Testing Laboratories and results are made available to the patient in an online portal.

Oregon Vital Hepatitis Elimination Plan Released

We are excited to share the <u>2024 – 2030 Oregon Viral Hepatitis Elimination Plan</u>, and our revamped <u>viral hepatitis webpage</u> with you. The plan was developed by Oregon Health Authority (OHA) staff with many community-based, advocacy, health care and agency partners.

There are Four Pillars, or goals, within this plan:

- 1. Prevent new infections;
- 2. Improve health outcomes;
- 3. Eliminate health disparities and inequities; and
- 4. Improve surveillance and data use.

As partners in health across Oregon there are many ways in which your expertise can assist in micro-elimination of HCV in your community. Specifically, consider your role in:

- Implementation of CDC viral hepatitis
 <u>B</u> and
 <u>C</u> testing guidelines;
- Dissemination of the <u>American College of Obstetrics and Gynecology viral</u> hepatitis information for pregnant people;
- Dissemination of information on the <u>Oregon Hepatitis B Prevention Program</u> <u>services</u>; and
- Implementation of <u>hepatitis A and B adult vaccine guidelines</u>.

Remember, you don't have to do this work alone! We are very interested to partner with you and others in your community to prevent, identify, and treat or cure viral hepatitis. Together we can support all people living with, or at risk for, viral hepatitis to get the care and treatment they deserve.
