The RH Program revised our Pregnancy Options Brochure last year to include more client-centered language and some updated resources, such as the All Options Talkline and the Lilith Clinic. It also has beautiful new graphics created by our graphic designer, Tony Diep. The updated brochures are available in Word and Adobe. The sections for "Parenting," "Adoption," and "Additional Resources" are editable and intended for you to add your relevant local organizations such as prenatal care providers, local WIC office, social services agencies, etc.

This brochure is intended to help certified agencies meet the requirement that: "Clinics must offer/provide written information about all pregnancy options. It must be written in a factual and non-directive manner and include contact information for agencies that give medically-accurate, unbiased information about the option(s) for which they are being listed." Since crisis pregnancy centers (also known as pregnancy resource centers or anti-abortion centers) may not provide medically-accurate, unbiased information, please do not list them on this brochure. If you are unsure if an organization/clinic in your area is a crisis pregnancy center, you can look at the Crisis Pregnancy Center map or contact the RH Program.

Opportunity to Participate in the Evaluation of a Contraceptive Clinical Decision Aid

Power to Decide, in partnership with Child Trends and the University of California, San Francisco, is implementing and rigorously evaluating Let's Talk, a multi-level intervention addressing adolescents and providers that includes both in-person and online components. As part of the evaluation, the research team is recruiting 30 health centers across the US to enroll adolescent patients assigned female at birth who are seeking care for a wellness visit or sexual and reproductive health services. The Let's Talk intervention includes a contraceptive decision aid that aims to improve equitable delivery of contraceptive services by offering concrete tools to strengthen patient-centered contraceptive counseling for adolescents.

By participating in the evaluation of Let's Talk, health centers can help determine if this new care model is effective at increasing patient-centered contraceptive counseling and use of preferred contraceptive method among adolescents. Health centers selected to participate in this study also will receive up to a \$8,000 stipend, paid in installments. Adolescent Health Well Visits

Well visits are the core of many patient-provider relationships. But too often, these regular appointments are hurried or skipped altogether. Even worse, the physical exams can be triggering for young people who may have experienced trauma.

These concerns motivated the development of AHI's latest resource, Improving and Increasing Adolescent Well Visits. This Timely Topic module will guide providers through the elements of a quality well visit, determine clinic strengths and priorities for well visit improvement, and evaluate the impact of improvement strategies on well visit rates. Through interactive activities and video vignettes from experts and adolescents, learners will have everything they need to make their well visits truly matter.

The AHI also developed a topic page with all of our materials on well visits and trauma -informed care, so you can expand your knowledge and change your practice for the better!
