Update: Increased Maximum Quantity for Emergency Contraception (EC)

Retroactively effective April 1, 2025 the maximum quantity allowed per Date of Visit (DOV) for Emergency Contraception (EC) increased from 2 units to 20 units.

This change ensures greater flexibility in supply management and meets the evolving needs of clients. If your acquisition costs exceed the maximum unit price, reach out to us – we're happy to review and adjust as needed.

Reminder: Minor Consent in Health Care in Oregon

House Bill 2022 (2023) updated a state statute related to minor consent for health care services. As of 2023, **minors of any age** can access reproductive health care services and information from a licensed provider without parental or guardian consent. This includes services such as:

- · contraception,
- pregnancy testing,
- prenatal, postnatal and delivery care,
- miscarriage management,
- · fertility care, and
- sexually transmitted infection (STI) testing and treatment.

For the purposes of consent, reproductive health services excludes voluntary sterilization and abortion, except in certain circumstances.
