Free Transportation is Available to RHAF Enrollees

NEMT (Non-Emergency Medical Transportation) services are available to clients who are enrolled in RHAF in most counties*. To receive the services clients must call their local brokerage which can be found on our Help with Transportation webpage. NEMT services for RH clients works the same as they do for OHP clients.

Please note that clients must already be enrolled in RHAF to be eligible for NEMT services. If you have a new client who needs transportation services, they can complete the RHAF enrollment form <u>over the phone or via video calls</u>. This would allow the client to seek transportation services for their first RH visit at your clinic.
