### **Health Equity Policy Toolkit**

Achieving health equity reduces harm to people who have been marginalized and increases life expectancy and quality of life for everyone. Current health inequities can be traced to policy choices that negatively impact (or "disenfranchise") communities, such as racist redlining policies and the traumatic historical practice of sending Native and Indigenous youth to boarding schools. Similarly, healthcare payment policies and a strained workforce result in geographic health disparities with rural counties lacking health system infrastructure such as a rural health clinic, Federally Qualified Health Center, or critical care hospital.

Recognizing that past policy choices across all levels of government resulted in an inequitable system and structural discrimination allows strategic amplification across multi-sector partners to address these historical wrongs and the resulting inequities. Public health leaders have an opportunity to support policies that center the needs of historically marginalized, disenfranchised, and underinvested communities to achieve health equity.

This toolkit, from the Association of State and Territorial Health Officials, is designed to support public health leaders in leveraging the policy development process to achieve health equity in their jurisdiction.

Basic infertility services are a core component of providing quality family planning services within the Title X Program. They are part of the broader scope of services centered on supporting clients in achieving a healthy pregnancy, and supporting individuals and couples to achieve their reproductive goals. This webinar will provide an overview of the scope of basic infertility services within Title X projects along with strategies that strengthen the provision of infertility services to support clients in their reproductive goals. Participants will also learn about the role of Title X projects in providing quality, accessible, and equitable basic infertility services as an important component of the broader system of care for fertility assistance and infertility services. Speakers will share resources from the Reproductive Health National Training Center (RHNTC) and the National Clinical Training Center for Family Planning (NCTCFP) that can help family planning agencies and staff strengthen their provision of infertility services.

### **FAQ** for Implementing the No Surprises Act

The Centers for Medicare and Medicaid Services (CMS) has a new FAQ document about implementing Good Faith Estimates for uninsured and self-pay individuals under the No Surprises Act. The FAQ document answers questions on how providers and facilities that either offer sliding fee discounts or do not expect to bill a patient for services can comply with Good Faith Estimate requirements. Moving forward, some providers have the option to provide patients with abbreviated Good Faith Estimate forms.

In response to these updates, National Family Planning and Reproductive Health Association (NFPRHA) will release an updated version of its resource guide, Implementing the No Surprises Act in Family Planning Settings, in the coming month.

### **Updated Resource on Minor Consent and Confidentiality**

The Reproductive Health Program and Adolescent & School Health Program are pleased to share "Understanding Minor Consent and Confidentiality in Health Care in Oregon". This document, an updated version of the 2016 "Minor Rights: Access and Consent to Health Care," summarizes state statutes, federal laws and regulations related to minor consent and confidentiality in health care settings. Topics include consent for specific health care services, confidentiality and privacy, and disclosure and information sharing. It is geared toward providers in clinical settings, however parents/ guardians, youth workers, and minors may use it as a reference for understanding and maximizing minor confidentiality and privacy as it relates to health care.

This document will soon be available in Traditional Chinese, Simplified Chinese, Russian, Spanish and Vietnamese. Updated links will be posted on the ASH Resources webpage in the coming weeks. In addition, all RH Program clinics will receive 2 copies of this resource in both English and Spanish in the next several weeks. Questions?
