#### **Updated Resource on Minor Consent and Confidentially**

The Oregon Health Authority (OHA) Adolescent and School Health (ASH) Program and Reproductive Health (RH) Program are pleased to share the recently updated document "Understanding Minor Consent and Confidentiality in Health Care in Oregon, Version 3, December 2023". The revised document captures amendments to minor consent statute based on the passage of Oregon House Bill 2002 (2023) and corrects errors to a previous version that was distributed to RH Program and School-Based Health Center clinics and posted to the web in January 2023. These errors were related to information-sharing under HIPAA.

All RH clinics should have received 2 copies of this resources in both English and Spanish a few weeks ago.

### **Health Care Transition ECHO Virtual Training Opportunity** (March – May)

Registration is now open for the Waisman Center's Health Care Transition ECHO virtual training series. This free, national 6-session series will be offered March to May 2024 1:30 pm – 3:00 pm on the 2nd & 4th Fridays of each month. Health care transition (HCT) is the process of preparing youth and young adults for the transition to a healthy adulthood. This ECHO is for health care providers across the US who work with youth and young adults with intellectual and developmental disabilities. This includes primary and specialty care providers, advanced practice providers (NP/PA), nurses, social workers, and any other provider interested in transition. Participants will learn and share strategies to support youth and young adults with intellectual and developmental disabilities to direct their own transition from pediatric to adult care and a healthy adulthood.
