



WIC Community Innovation and Outreach Project (CIAO) Grants Awarded

- The U.S. Department of Agriculture (USDA), through a cooperative agreement with USDA's Food and Nutrition Service (FNS) and the Food Research & Action Center (FRAC), has awarded \$16 million into 36 projects aimed at testing innovative outreach strategies to increase participation and equity in WIC
- Two of the 36 projects were awarded to Lincoln County and Confederated Tribes of Warm Springs

- The project aims to reduce disparities and increase WIC enrollment for Hispanic and Indigenous Guatemalan participants in Lincoln County
- The project will strengthen partnerships between healthcare providers and community-based organizations, employ innovative outreach strategies that include expansion of satellite clinics, offer dental services monthly to WIC clients, increase the number of Certified/Qualified Medical Interpreters, and create multilingual radio and television ads, as well as ads on relevant platforms such as WhatsApp
- Lessons learned from streamlining communication and referral processes between community-based organizations and professional healthcare organizations can be adapted to other priority populations

- The project aims to increase awareness within their community about WIC's benefits and services and to increase enrollment and retention of eligible participants living in rural areas in or around the Warm Springs reservation
- Strengthen knowledge about the WIC program through a social media, radio, and newspaper messaging campaign.
- Strengthen Tribal food systems and rural WIC enrollment and outreach efforts via partnering with the Tribally-run food bank and Indian Health Services to conduct remote mobile WIC clinics. Educational, culturally appropriate, and motivational WIC billboards will also be installed in the nearest town of Madras
- This project will adapt known outreach strategies (billboards, media campaigns, mobile WIC clinics, and community events) to best reach The Confederated Tribes of Warm Springs' diverse community
- Lessons learned from this project can be adapted by other Tribally-run WIC clinics nationwide

Formula Updates: Similac Sensitive RTF

The temporary rebate for the 32-ounce bottle of Similac 360 Total Care Sensitive Ready-to-Feed ends May 31, 2023

Similac 360 Total Care Sensitive RTF in the 32-ounce bottle will be **removed** from TWIST and will not be available to buy starting June 1, 2023.

Participants assigned **Similac Sensitive Ready-to-Feed (RTF)** in TWIST now have the following two options:

- Similar Sensitive Ready-to-Feed (RTF) 32-ounce bottle
- Similac 360 Total Care Sensitive RTF six pack of 8-ounce bottles

Options to offer participants:

- Transition off the RTF to Similac Sensitive powder, when possible.
- Similac Sensitive RTF in a 32-ounce bottle.
- Similac 360 Total Care Sensitive RTF in the 8 oz bottles
