State updates

Korina: Breastfeeding Peer Counseling Expansion project:

- BFPCX Linn is the pilot – fulfilling the host agency role. Contact Korina if your agency has questions about the program.
- A plan is being developed to implement the new FNS training platform. The team is currently reviewing this curriculum and discussing a delivery method. Contact Korina or Kelly for more information.

Bonnie: Pumps

- New Evolve pumps are delayed due to supply chain problems.
- Redistribution of pump-in-styles between agencies is in process now.
- We are discontinuing the process of changing benefit issuance to 1 month for an overdue pump. CPAs no longer need to change benefit issuance – it will stay at 3-month issuance.
- Important to track pumps via phone calls and by sending a letter.
