
Join Multnomah County REACH and WIC for a town hall to ignite awareness of the many ways we can all get involved in supporting lactating families in our community.

New FNS Required Breastfeeding Training - Update:

Initial Roll Out

- Remote training October 4 November 29
- 7 sessions covering levels 1-3 (not level 4)
- Instructor: Cathy Carothers
- CEs available

After Initial Roll Out (Long Term)

- 4 breastfeeding study modules, 1 for each level
- Level 4 released first
- Levels 2-4 self study followed by remote training with state staff
- More information and timeline coming

Formula update

- Breaking news: the rebates on non-contract formulas are in place until **December 31, 2022, or 60 days after the expiration of the COVID-19 disaster declaration.**
- Eventually, we will need to remove all of the alternative manufacturers and store brand formulas from our APL.
- What can we do now to help our families with this transition?
 - Encourage all new non-breastfeeding infants who enroll in WIC to use a contract Abbott formula.
 - Start talking with families currently using alternative formulas to transition back to Abbott.
- How do we address mistrust of Abbott formulas?



Risk Update In-Service




- The 2022 Risk Update In-Service is delayed
- Awaiting further guidance from USDA/FNS
- It will include information about blood lead level (new cutoff from CDC) and nutrition support related to lead poisoning prevention
- We aim to release it as soon as we're able to
- The due date for completion is extended to 12/30/22
